Before Igniting ANY Burn - Contact local fire control and/or law enforcement authorities.

<p>All burners MUST:</p> <ul style="list-style-type: none"> Obtain a permit (www.burnpermits.mt.gov) from your local fire control authority. <p>All burners in Western Zone MUST:</p> <ul style="list-style-type: none"> Complete a “Winter Time Open Burning Request Form” from DEQ and receive a Burn Identification Number (BIN) Call 406-444-3490 the morning of your burn to obtain final approval (for weekend burns call before 4pm on Friday) Approved burns will be displayed on the map on the www.burnclosures.mt.gov. <p>In Eastern Zone all burners MUST:</p> <ul style="list-style-type: none"> Notify DEQ prior to ignition 			<p>All burners MUST:</p> <ul style="list-style-type: none"> Obtain a permit (www.burnpermits.mt.gov) from your local fire control authority. Check for good ventilation conditions prior to your burn. Be aware that permits can be restricted based on fire danger potential by your local fire authority. 					<p>All burners MUST:</p> <ul style="list-style-type: none"> Obtain a permit (www.burnpermits.mt.gov) from your local fire control authority Check www.burnclosures.mt.gov the morning of the burn or call the Ventilation Hotline at 800-225-6779 If open burning is closed in your county all burning is prohibited*. If open burning is not restricted, be aware of local conditions and burn smart. 			

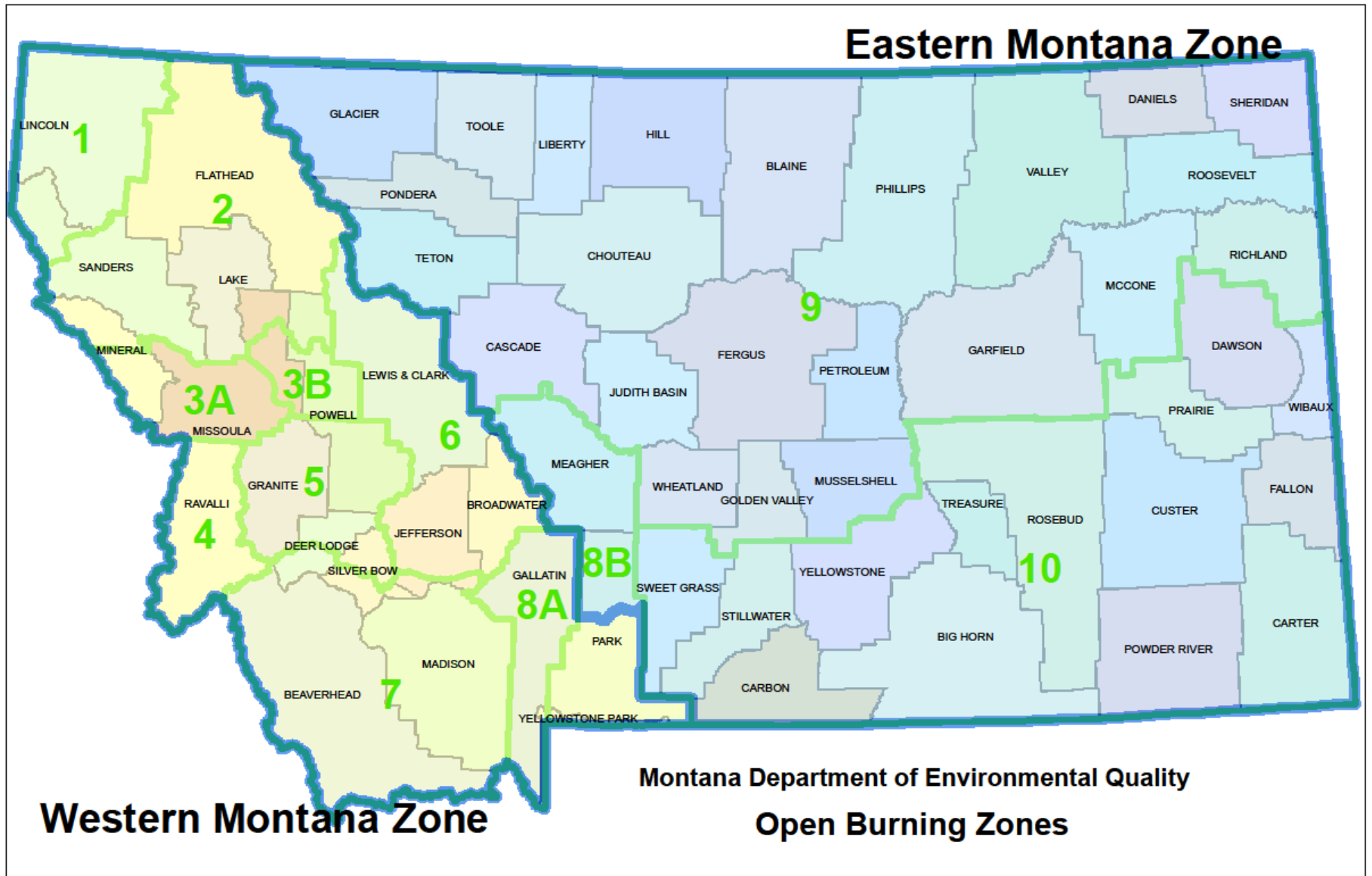

Items Banned from Open Burning

Eastern Montana Open Burning Zone: Big Horn, Blaine, Carbon, Carter, Cascade, Chouteau, Custer, Daniels, Dawson, Fallon, Fergus, Garfield, Glacier, Golden Valley, Hill, Judith Basin, Liberty, McCone, Meagher, Musselshell, Park (that portion north of Interstate 90), Petroleum, Phillips, Pondera, Powder River, Prairie, Richland, Roosevelt, Rosebud, Sheridan, Stillwater, Sweet Grass, Teton, Toole, Treasure, Valley, Wheatland, Wibaux, and Yellowstone. Western Montana Open Burning Zone: Beaverhead, Broadwater, Deer Lodge, Flathead, Gallatin, Granite, Jefferson, Lake, Lewis & Clark, Lincoln, Madison, Mineral, Missoula, Park (that portion south of Interstate 90) Powell, Ravalli, Sanders, and Silver Bow.
