Designed as a separate, non-regulatory, program within the DEQ, the Small Business Environmental Assistance Program serves to assist Montana businesses to understand and comply with applicable environmental regulations.

Within the Small Business Environmental Assistance Program exists the Small Business Ombudsman (SBO), and the Small Business Compliance Assistance Advisory Council (SBCAAC).

Small Business Ombudsman

The Small Business Ombudsman serves to:

- Provide free assistance to help Montana's small businesses deal with the complexities of state and federal environmental regulations and permitting; and



- Represent the interest of small business before the DEQ and other local, state, and federal agencies regarding the requirements of the state and federal Clean Air Act.

Small Business Compliance Assistance Advisory Council

- Seven (7) appointed members serve as advisors to DEQ regarding the needs of small businesses.
- Consults with small businesses concerning the implementation and application of environmental regulations.

Assistance from the SBEAP is free, and imposes no obligation on Montana businesses.

How Much Does the Service Cost?

The services of the SBEAP are free to small businesses.

Who is Eligible to Receive Assistance?

Any independently-owned Montana small business with fewer than 100 employees is eligible to receive assistance from the SBEAP.

Will DEQ or EPA Enforcement Programs Know that I Requested Assistance from the SBEAP?

No, the SBEAP operates as an independent program. Assistance requests received by the office are confidential and are not shared with DEQ or EPA Enforcement, except in cases of imminent danger to human health or the environment.
