Chairman Russell called for a motion to initiate the rulemaking. Mr. Rossbach so MOVED. Mr. Marble SECONDED the motion. The motion CARRIED with a unanimous VOTE.

III.A.2 Amend ARM 17.30.610 to change the water-use classification for two water body segments in the Dry Fork of the Marias River drainage.

Mr. Bukantis provided an overview of the rule change and a brief discussion took place. Mr. Shelvin, Mayor of Conrad, commented in support of the rule change.

Chairman Russell called for a motion to initiate the rulemaking. Mr. Rossbach so MOVED. Mr. Marble SECONDED. The motion CARRIED with a unanimous VOTE.
