- Site map showing where equipment will be installed, including area of all excavation. A copy of an internet-based satellite map with project location and soil disturbance indicated is sufficient.
- Copy of warranty deed for property where project will be located.
- Copy of homeowners or other insurance on property improvements where project will be located.
- Documentation of income:
  - Three most recent paystubs for regular earnings **AND**
  - Documentation of any other income to be considered for loan qualification (i.e. disability, pension, Social Security, etc.) **OR**
  - If self-employed, a copy of your most recent tax return, including schedules that detail income and expenses.
