The ExxonMobil Billings Refinery, 700 ExxonMobil Road, Billings, Montana, has submitted a permit modification request to the Montana Department of Environmental Quality (DEQ) to modify their Montana Hazardous Waste Permit MTHWP-17-01. The permit revision is necessary to incorporate changes to the New East Land Treatment Unit (NELTU) and Old East Land Treatment Unit (OELTU) as a result of a new rail car storage development project. The hazardous waste permit provides requirements for post-closure care of the NELTU and OELTU as well as Facility-wide corrective action. The modification request is being submitted under Chapter 40 of the Code of Federal Regulations (CFR), Part 270.

This notice is to inform the public of the permit modification request and to seek their participation in the decision-making process. During the public comment period, the public may submit written comments to DEQ. The comment period will extend from January 22, 2021, to March 23, 2021.
