**Name of Project:** Bryant No. 3 Subdivision Community Wastewater Facility

**Type of Project:** discharge of treated domestic wastewater to ground water under the Montana Ground Water Pollution Control System (MGWPCS) permit program.

**Description of Project:** This Environmental Assessment (EA) is for a MGWPCS permit renewal (MTX000182) for the Bryant No. 3 Subdivision Community Wastewater Facility(facility). The MGWPCS permit reauthorizes the Bryant No 3. Subdivision Homeowner's Association Inc. (permittee) to discharge treated wastewater from a subsurface discharge structure (Outfall 001) into Class I ground water. The scope of this EA addresses the operation and discharge of the wastewater treatment and disposal system. The magnitude and significance of potential impacts are summarized below (bullet #26).

**Agency Action and Applicable Regulations:** The proposed action is to issue an individual MGWPCS permit that contains effluent limits and effluent monitoring requirements. The permit is issued under the authority of the Montana Water Quality Act, the Montana Ground Water Pollution Control System, and the Montana Numeric Water Quality Standards in the Department Circular DEQ-7.

**Summary of Issues:** The purpose of this action is to regulate the discharges of pollutants to state waters from the regulated facility. Issuance of an individual permit will require the permittee to implement, monitor, and manage practices to prevent pollution and the degradation of ground water.

Are there special reclamation considerations?</p>	<p><b>[N]</b> No significant impacts have been identified.</p> <p>Discharge will increase moisture in the vadose zone. There are no limiting layers present in the soil profile that would impede continued treatment of effluent discharged from the drainfield.</p>
<p>2. WATER QUALITY, QUANTITY AND DISTRIBUTION: Are important surface or groundwater resources present? Is there potential for violation of ambient water quality standards, drinking water maximum contaminant levels, or degradation of water quality?</p>	<p><b>[N]</b> The facility covered under this permit must show evidence of treatment capable of meeting the established effluent limitation which was derived from the most restrictive ground water quality standards and nondegradation-nonsignificance criteria. This effluent limitation, along with special conditions and standard conditions of the permit has been developed to maintain the beneficial uses of all state ground waters including drinking water. Facilities must be able to meet this restrictive effluent limitation prior to discharge.</p> <p>Ground water monitoring at the hydraulically downgradient boundary of the mixing zone is maintained within the permit renewal. Please refer to the Fact Sheet document for further details. Ground water in this area is considered Class I with a specific conductance less than 1,000 µS/cm. A standard mixing zone has been authorized in prior permits.</p> <p>All discharge disposal structures must meet the minimum set back requirements which includes surface water, flood plains, ditches and springs. Are any rare plants or cover types present?</p>	<p>[N] This system is currently built and operating. There are two vascular species of concern and one potential species of concern identified in the Natural Heritage Database as occurring within one mile of this site.          These vascular species are; Lesser Rushy Milkvetch, Wedge-leaf Saltbush and the potential species is Small Yellow Lady's-slipper.</p>
<p>5. TERRESTRIAL, AVIAN AND AQUATIC LIFE AND HABITATS: Is there substantial use of the area by important wildlife, birds or fish?</p>	<p>[N] Eight bird species and three mammal Species of Concern were identified in the Natural Heritage Database as occurring within one mile of the site of this permit renewal. The mammal Species of Concern are; Little Brown Myotis, Horary Bat and Spotted Bat. The bird Species of Concern are; Great Blue Heron, Veery, Pinyon Jay, Brewer's Sparrow, Evening Grosbeak, Green-tailed Towhee, Cassin's Finch and Clark's Nutcracker.          This system is currently built. This permit renewal will not impact any new habitat.</p>

All discharge disposal structures must meet the minimum set back requirements which include surface water, flood plains, ditches and springs. [N] Most drainfields are constructed sub surface. Most wastewater treatment systems are enclosed within buildings located on pre-disturbed lands previously used for agriculture practices.
10. DEMANDS ON ENVIRONMENTAL RESOURCES OF LAND, WATER, AIR, OR ENERGY: Will the project use resources that are limited in the area? Are there other activities nearby that will affect the project? Will new or upgraded power line or other energy source be needed?	[N] This wastewater treatment system is in place and operating. The renewal of the operating permit will not create additional demand on resources.
11. IMPACTS ON OTHER ENVIRONMENTAL RESOURCES: Are there other activities nearby that will affect the project?	[N] This wastewater treatment system is in place and operating. The renewal of the operating permit will not create additional impacts on the local environmental resources.

[N] Wastewater treatment systems may be owned and operated by local communities or sewer districts. These systems are a vital tool in protection of their own public and environmental health.

[N] This wastewater treatment system is constructed and operating. The renewal of this operating permit will not affect access to recreation o wilderness activities.
19. DENSITY AND DISTRIBUTION OF POPULATION AND HOUSING: Will the project add to the population and require additional housing?	[N] This wastewater treatment system is constructed and operating. The renewal of this operating permit will not affect populations or housing.

21. CULTURAL UNIQUENESS AND DIVERSITY: Will the action cause a shift in some unique quality of the area?	[N] This wastewater treatment system is constructed and operating. The renewal of this operating permit will not affect cultural uniqueness and diversity.

24. **Description of and Impacts of other Alternatives Considered:**

- A. No Action: Under the “No Action” alternative, the Department would not issue this ground water discharge permit. “No Action” may lead to the creation of non-permitted wastewater systems. This may result in a net negative impact to ground water quality as the permit would prevent pollution and degradation of state waters.
- B. Approval with Modification: The Department has not identified any necessary modifications to grant approval.

25. **Cumulative Effects**: The ground water in the vicinity of the existing discharge structure is Class I ground water with a specific conductance less than 1,000 µS/cm. DEQ has developed effluent limitations based on water quality standards to maintain the beneficial uses of this state ground water. The permit prohibits pollution of state waters. The permit includes monitoring, reporting, and corrective action requirements to establish, confirm, and maintain compliance with permit limitations. Please refer to the Fact Sheet document for additional information.

26. **Summary of Magnitude and Significance of Potential Impacts:**

Impacts were assessed with the assumption that the facility will comply with the terms and conditions of the permit. Violations of the permit could lead to significant adverse impacts to state waters. Violations of the permit are not an effect of the agency action since the permit itself forbids such activities. However, the Department has taken steps to ensure that violations do not occur. The Department provides assistance to applicants in understanding and implementing the requirements of the permit. The Department also conducts periodic inspections of permitted facilities, and identifies potential problems

with design or management practices. If violations of the permit do occur, the Department will take appropriate action under the water quality act. Enforcement sanctions for violations of the permit include injunctions, civil and administrative penalties, and cleanup orders.

27. **Preferred Action Alternative and Rationale:** The preferred action is to reissue the existing individual MGWPCS discharge permit. This action is preferred since the permit provides a regulatory mechanism for protecting ground water quality by applying effluent limits and monitoring requirements to the discharged wastewater.

**Recommendation for Further Environmental Analysis:**

**Rationale for Recommendation:** An EIS is not required under the Montana Environmental Policy Act because the project lacks significant adverse effects to the human and physical environment.

All comments received or postmarked prior to the close of the public comment period will be considered in the formulation of the final permit. DEQ will respond to all substantive comments pertinent to this permitting action and may issue a final decision within thirty days of the close of the public comment period.

All persons, including the applicant, who believe any condition of the draft permit is inappropriate, or that DEQ's tentative decision to deny an application, terminate a permit, or prepare a draft permit is inappropriate, shall raise all reasonably ascertainable issues and submit all reasonably available arguments supporting their position by the close of the public comment period (including any public hearing). All public comments received for this draft permit will be included in the administrative record and will be available for public viewing during normal business hours.

Copies of the public notice are mailed to the applicant, state and federal agencies, and interested persons who have expressed interest in being notified of permit actions. A copy of the distribution list is available in the administrative record for this draft permit.
