## PURPOSE OF PUBLIC NOTICE

The purpose of this notice is to state the Department's intention to issue a wastewater discharge permit to the facility listed in this notice. This permit is issued by the Department under the authority of 75-5-402, Montana Code Annotated (MCA); the Administrative Rules of Montana (ARM) 17.30.1301 *et seq.*, Montana Pollutant Discharge Elimination System (MPDES); and Sections 402 and 303 of the Federal Clean Water Act. The Water Protection Bureau has prepared a draft permit for the facility listed below. DEQ is proposing a draft Montana Pollutant Discharge Elimination System (MPDES) permit renewal for the City of Dillon waste water treatment plant (WWTP). The WWTP is a minor publicly owned treatment works upgraded from a lagoon system to mechanical plant in 2014. The WWTP has an average daily design flow of .75 million gallons per day for a design population of 5,200. Current population served is 4,200.

In this proposed permit, DEQ granted a standard mixing zone for ammonia and N + N and a variance for total nitrogen (TN) and total phosphorus (TP). The City of Dillon WWTP is now a mechanical plant and will be held to National Secondary Standards (NSS) for their technology based effluent parameters.

During the public comment period provided by the notice, the Department will accept requests for a public hearing. A request for a public hearing must be in writing and must state the nature of the issue proposed to be raised in the hearing (ARM 17.30.1373).

The Department will respond to all substantive comments and issue a final decision within sixty days of this notice or as soon as possible thereafter. The complete administrative record, including permit application and other pertinent information, is maintained at the Water Protection Bureau office in Helena and is available for review during business hours.
