## PURPOSE OF PUBLIC NOTICE

The purpose of this notice is to state the Department's intention to issue a General Permit as described in this notice and to hold a public hearing on the issuance of this permit. This permit is issued by the Department under the authority of 75-5-402, Montana Code Annotated (MCA); the Administrative Rules of Montana (ARM) 17.30.1301 *et seq.*, Montana Pollutant Discharge Elimination System (MPDES); and Sections 402 and 303 of the Federal Clean Water Act. The Water Protection Bureau has prepared a draft permit for the facility listed below. Copies of the draft permit, fact sheet and environmental assessment are available upon request from the Water Protection Bureau or on the Department's website www.deq.mt.gov.

The renewal of this General Permit for Storm Water Discharges Associated with Construction Activity will continue to provide statewide general permit coverage for owner/operators of construction activities that discharge storm water to state surface waters.
