Name of Project: Many Glacier Wastewater Treatment Plant

**Type of Project:** Proposed discharge of treated domestic wastewater to ground water under the Montana Ground Water Pollution Control System (MGWPCS) permit program.

Location of Project: Section 12, Township 35 North, Range 16 West

City/Town: Babb, MT

County: Glacier

**Description of Project**: This Environmental Assessment (EA) is for a MGWPCS permit (MTX000221) for the Many Glacier Wastewater Treatment Plant (facility). The proposed MGWPCS permit reauthorizes the Glacier National Park (permittee) to discharge treated wastewater from four IP ponds (Outfall 001) into Class I ground water. The magnitude and significance of potential impacts are summarized below (bullet #26).

**Agency Action and Applicable Regulations**: The proposed action is to reissue an individual MGWPCS permit that contains ground water compliance and monitoring limits. The permit is issued under the authority of the Montana Water Quality Act, the Montana Ground Water Pollution Control System, and the Montana Numeric Water Quality Standards in the Department Circular DEQ-7.

**Summary of Issues**: The purpose of this action is to regulate the discharges of pollutants to state waters from the regulated facility. Issuance of an individual permit will require the permittee to implement, monitor, and manage practices to prevent pollution and the degradation of ground water.

Are there special reclamation considerations?	<b>[Y]</b> Discharge will increase moisture in the vadose zone. No continuous limiting layers were identified in the soil profile. The facility is located entirely within Glacier National Park, an area with a unique geologic history.

Is there potential for violation of ambient water quality standards, drinking water maximum contaminant levels, or degradation of water quality?	<b>[N]</b> The facility covered under this permit must show evidence of treatment capable of meeting the established ground water limitation which was derived from the most restrictive ground water quality standards. This ground water limitation, along with special conditions and standard conditions of the permit has been developed to maintain the beneficial uses of all state ground waters including drinking water. This facility must be able to meet this restrictive ground water limitation to continue wastewater discharge.
	Ground water monitoring at the hydraulically downgradient boundary of the mixing zone is maintained within the permit renewal. Please refer to the Fact Sheet document for further details.
	All discharge disposal structures must meet the minimum set back requirements which includes surface water, flood plains, ditches and springs. [N] Best management practices are encouraged during construction of the replacement treatment system and drainfield to mitigate particulates produced. Are any rare plants or cover types present?	<ul><li>[N] Based on a search of the Natural Heritage Database, there are two vegetative species listed as either S1 or S2 for this section of Glacier County in the facility area: the moonwort and the Pale Corydalis.</li><li>System is already built.</li></ul>

TERRESTRIAL, AVIAN AND AQUATIC LIFE AND HABITATS: Is there substantial use of the area by important wildlife, birds or fish?	<ul> <li>[Y] Based on a search of the Natural Heritage Database, there are three species listed as either S1 or S2 in the vicinity of the facility: the Meltwater Lednian Stonefly, the Westslope cutthroat trout, and the grizzly bear.</li> <li>System is already built.</li> </ul>
6. UNIQUE, ENDANGERED, FRAGILE OR LIMITED ENVIRONMENTAL RESOURCES: Are any federally listed threatened or endangered species or identified habitat present? Any wetlands? Species of special concern?	[N] See #4 and #5 above. All discharge disposal structures must meet the minimum set back requirements which include surface water, flood plains, ditches and springs. Will there be excessive noise or light?	<b>[N]</b> The system is not prominent or visible in the populated areas of the park. It is in an area that is off limits to visitors. There is not excessive noise or light emitted from the system.	
10. DEMANDS ON ENVIRONMENTAL RESOURCES OF LAND, WATER, AIR, OR ENERGY: Will the project use resources that are limited in the area? Are there other activities nearby that will affect the project? Will new or upgraded power line or other energy source be needed?	<b>[N]</b> No significant impacts have been identified. The Department analysis indicates that the water quality standards will not be exceeded outside of the Department modified mixing zone for the parameters expected in the effluent. Monitoring and reporting requirements especially those of the groundwater monitoring well network that exists on the site ensures the identification of significant variations in the wastewater and ground water quality.

# 24. Description of and Impacts of other Alternatives Considered:

- A. <u>No Action</u>: Under the "No Action" alternative, the Department would not issue this ground water discharge permit. "No Action" may lead to the creation of non-permitted wastewater systems. This may result in a net negative impact to ground water quality as the permit would prevent pollution and degradation of state waters.
- B. <u>Approval with Modification</u>: The Department has not identified any necessary modifications to grant approval.

## 25. Cumulative Effects:

DEQ conducted a Cumulative Effects and Reasonable Potential analysis in use of sitespecific information and effluent characteristics collected over the previous permit cycle. The analysis determined that an exceedance of a respective water quality standard is not likely. Please refer to the associated Fact Sheet document for additional information.

The ground water in the vicinity of the existing discharge structure is Class I ground water with a specific conductance less than 1,000  $\mu$ S/cm. DEQ has developed ground

water limitations based on water quality standards to maintain the beneficial uses of this state ground water. The permit prohibits pollution of state waters. The permit includes monitoring, reporting, and corrective action requirements to establish, confirm, and maintain compliance with permit limitations. Please refer to the Fact Sheet document for additional information.

## 26. Summary of Magnitude and Significance of Potential Impacts:

Impacts were assessed with the assumption that the facility will comply with the terms and conditions of the permit. Violations of the permit could lead to significant adverse impacts to state waters. Violations of the permit are not an effect of the agency action since the permit itself forbids such activities. However, the Department has taken steps to ensure that violations do not occur. The Department helps applicants in understanding and implementing the requirements of the permit. The Department also conducts periodic inspections of permitted facilities, and identifies potential problems with design or management practices. If violations of the permit do occur, the Department will take appropriate action under the water quality act. Enforcement sanctions for violations of the permit include injunctions, civil and administrative penalties, and cleanup orders.

27. **Preferred Action Alternative and Rationale**: The preferred action is to reissue the existing individual MGWPCS discharge permit. This action is preferred since the permit provides a regulatory mechanism for protecting ground water quality by applying ground water monitoring limits and monitoring requirements to the discharged wastewater.

DEQ will respond to all substantive comments pertinent to this permitting action and may issue a final decision within thirty days of the close of the public comment period.

All persons, including the applicant, who believe any condition of the draft permit is inappropriate, or that DEQ's tentative decision to deny an application, terminate a permit, or prepare a draft permit is inappropriate, shall raise all reasonably ascertainable issues and submit all reasonably available arguments supporting their position by the close of the public comment period (including any public hearing). All public comments received for this draft permit will be included in the administrative record and will be available for public viewing during normal business hours.

Copies of the public notice were mailed to the applicant, state and federal agencies and interested persons who have expressed interest in being notified of permit actions. A copy of the distribution list is available in the administrative record for this draft permit.
