PURPOSE OF PUBLIC NOTICE

The purpose of this notice is to state the Montana Department of Environmental Quality's (DEQ) intention to issue a General Permit as described in this notice. This permit is issued by the DEQ under the authority of 75-5-402, Montana Code Annotated (MCA); the Administrative Rules of Montana (ARM) 17.30.1301 *et seq.*, Montana Pollutant Discharge Elimination System (MPDES); and Sections 402 and 303 of the Federal Clean Water Act. The Water Protection Bureau has prepared a draft permit for the facility listed below. PERMIT/CATEGORY: General Permit for Sand and Gravel Operations

GEOGRAPHIC REGION: Statewide

FACILITIES: Sand and Gravel Operations

RECEIVING WATERS: State Surface Water

PERMIT NUMBER: MTG490000

The renewal of this General Permit will continue to provide statewide general permit coverage for owners/operators of sand and gravel operations that discharge to state surface waters. The renewal is for a five-year cycle.

The General Permit allows sand and gravel operations that meet effluent limits and other conditions specified in the permit to discharge to state surface waters. This General Permit is applicable to sand and gravel mining operations which discharge mine dewatering water or process generated wastewater. The General Permit includes effluent limits and monitoring requirements for total suspended solids, oil & grease, and pH that protect the beneficial uses of the receiving water body.

A public hearing will be held on the draft general permit, fact sheet, environmental assessment, and DEQ's tentative determination on August 29, 2019 at 9:00 a.m. in DEQ's Lee Metcalf Building, Room 111 at 1520 E. Sixth Ave, Helena, MT.
