1.0 WELL INVENTORY SUMMARY

1.1 INTRODUCTION

This Private and Public Well Inventory addresses the requirements of remedial design/remedial action (RD/RA) Tasks F and G, and Supplemental Investigation Task L presented in the *Statement of Work for Spring 2005 Activities* dated August 2005 (Spring 2005 SOW) [Montana Department of Environmental Quality (DEQ) 2005].

The Burlington Northern (BN) Livingston Shop Complex site is being addressed under Montana's Comprehensive Environmental Cleanup and Responsibility Act (CECRA), which defines a "Facility" to include "any site or area where a hazardous or deleterious substance has been deposited, stored, disposed of, placed, or otherwise come to be located." [Section 75-10-701(4)(a)(ii), Montana Code Annotated (MCA)].

Consistent with this definition, the BN Livingston Shop Complex Facility (the Facility) includes the Livingston railyard and the surrounding area where hazardous or deleterious substances as defined under CECRA have been deposited, stored, disposed of, placed, or otherwise come to be located. The Facility is located in Park County, Montana with the majority of it within the City of Livingston. Livingston is located approximately 26 miles east of Bozeman, Montana and 100 miles west of Billings, Montana.

The DEQ has selected a remedial action for the Facility that is set forth in the *Record of Decision* (ROD) (DEQ 2001). DEQ and BNSF Railway Company (BNSF) negotiated the Spring 2005 SOW to address requirements and activities for initiating high priority portions of the selected remedy. This private and public well inventory has been prepared to satisfy the requirements identified in the following sections of the ROD and Spring 2005 SOW:

- ROD Section X.E – Monitoring and Maintenance
- Spring 2005 SOW Section 3.1.6 – Task F: Alluvial Aquifer Groundwater Volatile Organic Compound (VOC) Cleanup
- Spring 2005 SOW Section 3.1.7 – Task G: Groundwater Dissolved-Phase Petroleum Cleanup
- Spring 2005 SOW Section 3.2.4 – Task L: Investigation of VOCs in Bedrock Aquifer(s).

Since the private and public well inventory is a requirement of several tasks, it has been prepared as a stand-alone document designed to be used in conjunction with the documents prepared for Tasks F, G, and L (see Section 1.4).

BNSF has prepared this private and public well inventory to identify known domestic, commercial, industrial, irrigation, and monitoring wells within approximately 1/2 mile of:

- Alluvial aquifer groundwater containing chlorinated VOCs at or greater than the *Circular DEQ-7, Montana Numeric Water Quality Standards for Human Health* (DEQ-7 standard) dated February 2008 (or current version) required reporting limits (formerly referred to as WQB-7 standard)
- Alluvial aquifer groundwater containing dissolved-phase petroleum concentrations at or greater than Montana's *Tier 1 Risk-Based Corrective Action Guidance Document* dated September 2009 (or current version)
- Chlorinated VOC concentrations at or greater than the DEQ-7 standard required reporting limits in the bedrock aquifer(s), if present.

The search area for the well inventory was defined by using a rectangular area to represent an inner well search boundary. West of the Yellowstone River (i.e., to the approximate end of the Livingston railyard), the inner well search boundary generally encompasses the “approximate boundary of detectable contamination” defined by DEQ on Figure 2. The inner well search boundary rectangle was prolonged to the northeast, beyond the Yellowstone River, to approximately 500 feet northeast of the O’Hara well (02S/10E-5P01). Another rectangle (outer well search boundary) was placed 1/2 mile beyond the inner well search boundary. Known domestic, commercial, industrial, irrigation, and monitoring wells located within the outer well search boundary are included in this well inventory. The inner and outer well search boundaries are depicted on Figure 1.

In accordance with the Spring 2005 SOW, private wells identified within the area of dissolved tetrachloroethene (PCE) above the DEQ-7 required reporting limit of 0.5 micrograms per liter ($\mu\text{g/L}$), as defined by DEQ (see Figure 2), are sampled if the private wells have operational pumping systems.

1.2 AVAILABLE RESOURCES

The following available resources were used to the extent practicable to identify private and public wells located within the DEQ-defined boundary and compile the information presented in this document:

- Montana Bureau of Mines and Geology, Groundwater Information Center (GWIC) Database
- Montana Department of Natural Resources and Conservation (DNRC), Water Resources Division - Water Rights Database
- Montana Cadastral Mapping Project <<http://gis.doa.state.mt.us/index.html>>
- Envirocon, Inc. of Missoula, Montana (Envirocon).

1.3 INVENTORY

This private and public well inventory consists of summary tables, a well location map, copies of well logs for wells included in the inventory, and the results of the well survey(s) conducted by BNSF.

Table 1 presents a summary of the current inventory. This table includes:

- A unique Kennedy/Jenks Consultants assigned well number based on Township, Range, Section, and 40-acre tract in accordance with the U.S. Geological Survey (USGS) well numbering system. This well number is used to identify approximate well locations on Figure 1. The USGS well numbering system is described in Appendix A.
- DNRC water right number.
- GWIC identification number.
- Envirocon name (this name was previously used by Envirocon to identify the well).
- Well or water right owner as listed in the GWIC database.
- Name and address of current owner, to extent reasonably available.

Tables 2, 3, and 4 provide additional well information i.e., driller, date drilled, static water level, well depth, well construction/design, and well use. Copies of the well logs (if available) for wells listed in Table 1 are included in Appendix B.

BNSF recognizes that the potential exists for the presence of unregistered wells. In order to identify potential unregistered private wells in the area potentially underlain by

groundwater containing chlorinated VOC concentrations approaching the ROD-specified cleanup levels, BNSF developed a private well survey form [presented in Appendix H of *Task F Stage I – Part 1 Remedial Action Plan* (DEQ 2007)] that was initially mailed to residents within the estimated area in which chlorinated VOC concentrations exceed the ROD-specified cleanup levels and a buffer zone around that area in 2005. As required by DEQ in its letter to BNSF dated 8 September 2009, private well survey forms were mailed in November and December 2009 to property owners located within the outer well search boundary (see Figure 1). Returned surveys received to date with pertinent information regarding a well(s) on a property are provided in Appendix C. Appendix C has been updated to include “Late Returns” with pertinent well information that were received after the submittal of *Private and Public Well Inventory (Revision No. 4)* to DEQ in January 2010. A compilation of the November/December 2009 well survey returns (including those with no pertinent well information) has been provided to DEQ under separate cover.

1.4 DELIVERABLES

Periodic review and updates, if necessary, to this private and public well inventory will be conducted in the future as part of the following task deliverables and in accordance with the Spring 2005 SOW:

- Task F Stage I – Part 1 RA Report
- Task F Stage I – Part 2 RA Report
- Task G Stage I RA Report

- Task L Supplemental Investigation Report

- Annual reports.

Periodic review of the private and public well inventory will also be conducted in the future as required by DEQ and the inventory will be updated at least annually, as necessary. The periodic reviews will be conducted at least annually until a Controlled Groundwater Area is established pursuant to the ROD.

If the private and public well inventory requires updating (i.e., new wells identified), addenda to this document will be prepared and submitted to DEQ along with the aforementioned deliverables. If no new private and public well information is found during the periodic review(s), this information will be documented in the aforementioned deliverables.

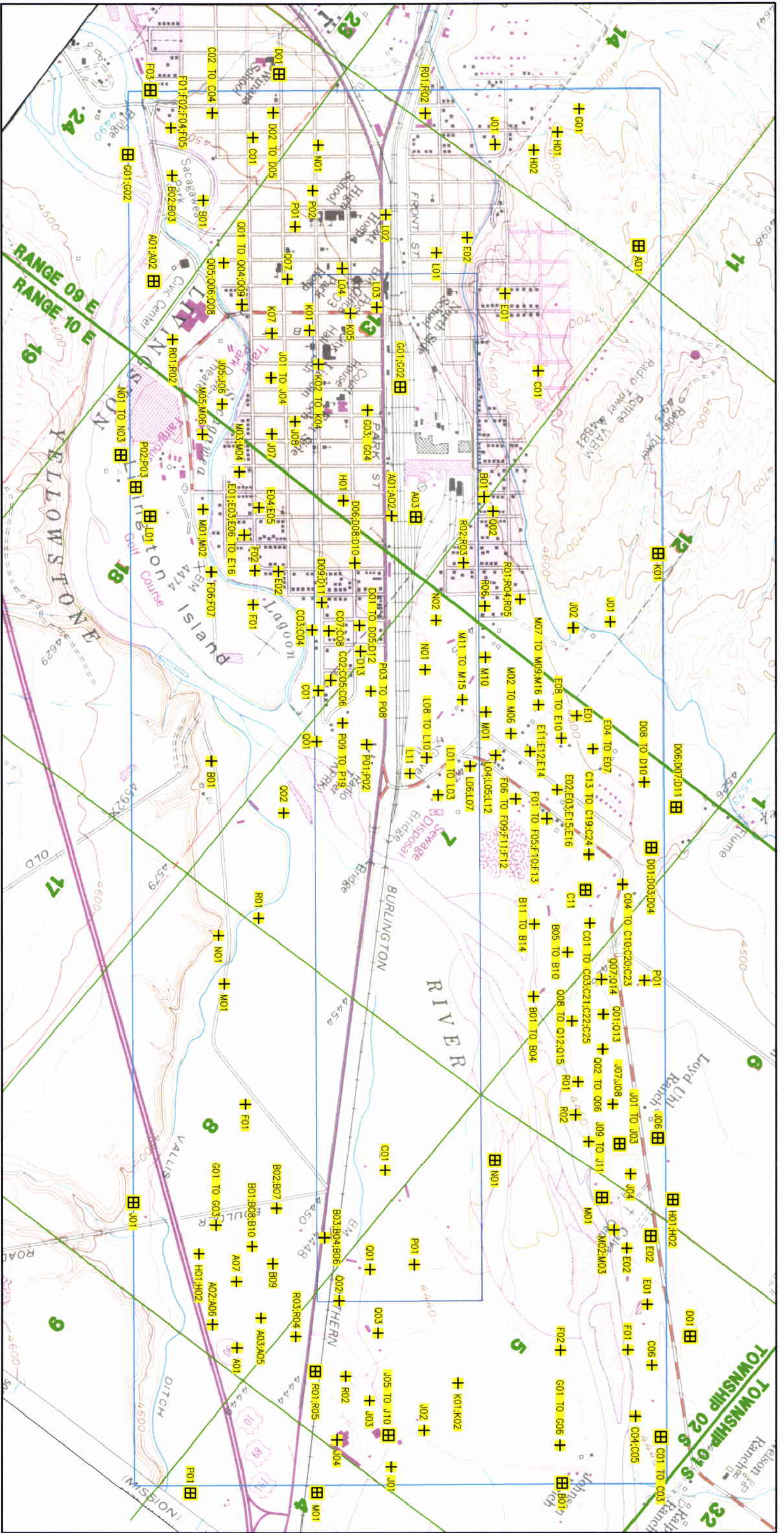

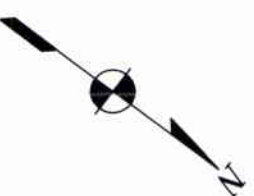
