MR. BOOHER: Yes. This is Marty Booher from Baker Hostetler. I'm on the telephone. I represent Westmoreland.

MR. STERUP: Rob Sterup, Brown Law Firm in Billings representing Talen Montana.

CHAIR DEVENY: Could the last person who spoke repeat your name for our Court Reporter.

MR. OBIE: Damon Obie and Andrew Wright, in-house attorneys for Talen Energy.

MR. FRANK: Good afternoon. This is Joshua Frank from Baker Botts on behalf of Talen. MR. HAIGHT: Adam Haight with Montana AFL-CIO.

CHAIR DEVENY: Anybody else?
MR. BUSBY: This is Dexter Busby.
CHAIR DEVENY: Welcome, Dexter. You're the fifth Board member present now. Besides myself we have John DeArment, and David, and Melissa. I'd like to remind those people on the phone to please mute your phones so we don't have a lot of feedback, and also when you speak, to identify yourself so that our Court Reporter can get the record correct in the minutes.

All right. So the purpose of this meeting is two fold: First to open the case in the matter of the Major Facility Siting Act certificate for Colstrip Units 3 and 4 that were received by the Board on May 17 th; and then the second part of our meeting will be to decide how we're going to consider the emergency motion that was filed by Westmoreland.

So the first thing the Board needs to do is in the matter of the Major Facility Siting Act. We have choices here. We can hear the case itself; we can assign it to the Hearings Examiner for procedural issues, and then do the rest ourselves; or we can assign it to the Hearing Examiner for the totality of the case, which would be for procedural and the rest of the case except for the final decision making, which would be of course by the Board.

So any discussion by Board members, or do you have a pleasure on what you would like to do with this case?

CHAIR DEVENY: Don't all speak at once.
(No response)
CHAIR DEVENY: I would like to suggest
that we assign this case to our Hearing Examiner for the totality. I think it's something that would best be handled by her. None of us have really ever taken on a full case before, for those of you Board members that are new, and I think this would be the best way to proceed. I would make a motion to do so.

MR. BUSBY: I'll second.
MR. DEARMENT: I'll second. This is John.

CHAIR DEVENY: I believe Dexter seconded that; is that correct? MR. BUSBY: Yes.

CHAIR DEVENY: Is there any discussion by Board members on the motion or the second?

CHAIR DEVENY: Hearing none --
MR. BUSBY: I think John wanted to say something. I couldn't hear him, though.

MR. DEARMENT: Yes. This is John. You beat me to it, Dexter. I was just seconding the Chair's motion.

CHAIR DEVENY: If there is no further discussion, let's have a vote on this motion. All those in favor of assigning the case in its totality to Sarah, please signify by saying aye. (Response)

CHAIR DEVENY: I believe we have all five votes as aye's. Are there any nay's in case I missed?

CHAIR DEVENY: Motion carries unanimously, so Sarah, it's in your court.

MS. CLERGET: Great.
CHAIR DEVENY: The second part of the case has to do with considering the --

MS. CLERGET: Well, wait a minute,
Chris. Unless you to modify or change the motion that you just made, you assigned it to me for a Hearing Examiner, so that means I have to --

CHAIR DEVENY: You have to do everything. Okay.

MS. CLERGET: If you want to change that, and you would like to keep it and make a decision on the emergency motion, you can do that.

CHAIR DEVENY: No, I don't. At this point I'm happy to turn it over to Sarah then.

MS. CLERGET: All right. So in that case, $I$ will contact the parties to determine how to proceed. So to the extent that all of the
parties are here, we can do that after this meeting adjourns, if everybody is amenable to that. And $I$ would prefer if that meant Westmoreland, DEQ; and $I$ think if Talen, $I$ don't know if you plan on intervening or not, but if you do, then please stay. So --

MR. FRANK: This is Joshua Frank for Talen. Yes, $I$ certainly will be involved, and would intervene in the proceeding. I'm on the phone. I think we have some people there in the room. I couldn't hear.

MS. CLERGET: We don't need to get into it right now, just for the purposes. I'll have a meeting with the parties after the Board is adjourned.

MR. FRANK: Okay. Very well.
CHAIR DEVENY: So that pretty much concludes our action items today. I will open this meeting up to public comment. The public is allowed to comment on anything except for contested cases, of which today is one. So are there any issues that anybody wants to bring before the Board besides contested cases?

MR. CHEREN: This is Robert Cheren from Baker Hostetler. Can we clarify for purposes of
assignment. I mean this is a situation where we might have to seek relief from a Court in an expedited fashion. So you're saying we're going to have a hearing today on the motion?

MS. CLERGET: Right after the Board adjourns.

MR. CHEREN: Right after the Board adjourns. Okay. Then we don't have anything else. Thank you.

CHAIR DEVENY: Any other further public comment?
