The Libby Asbestos Superfund Liaison is an employee of the Montana Department of Environmental Quality (Department), but serves as staff to the Libby Asbestos Superfund Advisory Team (Advisory Team). The Liaison shall represent the interest of Lincoln County and the State by assisting the Department in dealing with federal agencies related to the Libby asbestos superfund site (Site). This includes effectively and responsibly acting as the Advisory Team's and the State's primary point-of-contact for assigned projects and tasks associated with the Site. The successful candidate is responsible for leadership, administrative oversight, and management as related to the Libby Asbestos Superfund Site cleanup, including but not limited to developing and monitoring project milestones, budgets, and regulatory requirements; develop strategies while exercising considerable professional expertise and decision-making to achieve goals and implement advisory team recommendations; coordinate and administer the Advisory Team; draft and manage certain project documents; and regularly analyze and

report performance, develop recommendations for corrective action plans, and implement corrective action when required. Work environment includes both office and field settings.
