George Jamison: I don't have any comments or suggested changes to the report as I read it and we're near the end of the year here and I think about this time of year we encourage DEQ to try to make inquiries to EPA about updates to some of these estimates of balances of a couple of these funds. I would add that as a note, maybe something to throw on the to-do list to see if you can check and see if they will give you the information. Thank you. Chairman Gunderson: I would also ask Director, is it time to reach out again to EPA and ask them the status of that funding we continually question but we never seem to get an answer. I think they call that poking the bear. Director Dorrington: Yeah, I don't mind. Maybe Katie or Melody would want to comment on that. Katie Garcin-Forba: Yeah, I think both comments on the funding and current status from EPA and then what their plan is for the funds we've been asking about, we can prioritize that for 2024. If we get information pulled together prior to the next, first quarterly LASOC meeting, we'll certainly share that out to this group but we can prioritize that conversation as far as budgets with EPA and moving into next year. Yeah, we'll get that information gathered into the group. Chairman Gunderson: OK, great, Melody, maybe we need to put that on a permanent annual to-do list. 	nature of various things. Starting first with PEN notifications and second is informational requests and then
	the second other two where action items or requests. Some that were reimbursable in the context of what
	EPA said they'd reimburse. The non-reimbursables that we are talking about are things that deal with the
	NOEC, the developer properties and things of that nature. That is the way that list was divided was to look
	at different categories. It was not intended to speak to weather or not any of those, particularly the last
	two, it doesn't really capture weather or not they were actually reimbursed or what their disposition was.
	I suggest we might add a couple of explanatory footnotes to those two items and if Melody is interested,
	I'd be happy to work with her on that and we can bring something back to the next meeting. Melody

DEQ/EPA Site	Chairman Gunderson: DEQ/EPA site update, Melody. Melody Wunderlin: There aren't any updates on
Update –	OU6. For OU3 we're working on our last tech memo and getting some comments back on that and we are
Melody Wunderlin	expecting that feasibility study in May of 24. Chairman Gunderson: OK, Nick do you have anything on OU3
-Activities at OU3 &	at this time that you'd like to add. Nick Raines: Yeah, I think Melody already mentioned we're working
OU6	away on the feasibility study. Looking forward to getting a full draft in front of the agency's for review,
	early or middle of next year, early May I'll say. Maybe shifting gears to KDC operations up there. The dam
	and spillway, we completed construction on the upper half of the new spillway. Technically we finished
	construction, substantial completion in the October timeframe but then by the time the contractor was off
	site it was late November. So work has ceased up there for the year. We are now moving ahead with
	setting up everything for the lower half of that project and we'll continue construction into next year as we
	continue to evaluate and address other long term durability and stability items for the dam itself.
	Chairman Gunderson: Great, I guess just off the wall. You and I have talked about this. What would be a
	good time to get all the LASOC team together up there to do a site visit and get a better indication of how
	massive this project is. Nick Raines: Yeah, absolutely. We would love to get you up there. You know, we've
	had a lot of interest in site tours this last year, and we've had to kind of scale back and let folks know that
	right now, it's limited to our contractors, agency representatives and organizations like LASOC that have
	direct involvement in the project. So I think we can certainly co-ordinate getting you guys up there. We
	have the means and methods to get everyone up there for a tour. Obviously, weather plays a big part in
	timing and not sure what this winter is going to bring, what I would normally say ideal timeframe would be
	in May, because at that point, we're sure that we can get to the top of the mine. The road is in good
	condition, snow free and any repair that we need to do on the road and whatnot and before we start
	getting into fire season, however, this year it could come a little bit earlier if snow continues to be as
	limited as it has been so far, I'd probably say anytime in that April, May, June range is kind of the ideal time
	to schedule something. Chairman Gunderson: OK, lets you, Mandy and myself keep talking about it and
	see if we can nail down a time and give everybody, the director and any staff from DEQ ample notice to
	where we don't slam them in an overnight type thing. Nick Raines: Absolutely. Chairman Gunderson:
	Yeah, I think that'd be great. OK, anything else up there that's going on. Nick Raines: We've got a lot of
	work, obviously, going on. The feasibility study, as Melody mentioned, we're kind of full bore developing
	that, but as far as other kind of general update, I think covers it. Any questions for me on OU3. Chairman
	Gunderson: When can we get up and see it. Nick Raines: I guess I do, now that I mentioned that, I do have
	a little side note because I know Commissioner Teske is not on today. I had heard through the grapevine
	that he had a couple of different questions, one primarily related to some property that Kootenai
	Development Company owns across the River. I think he drove by and seen some logging operation going

on there and had some questions about it. We've been actively managing the property that we own. I think we have eight lots on that side of the river, on the Haul Road side that was long overdue for some
forest management, and really some wildfire fuels reduction. We went in and have really been focused on clearing diseased trees and undergrowth for that project. Once most of the logging done, we'll do some mastication and other work. Primarily from a forest health and fire fuels reduction effort. Chairman
Gunderson: Super, it's good to hear that we're able to do some sort of fuels reduction and forest management without litigation. That is kind of an odd thing lately. OK, well moving on.
