O&M Update – Melody Wunderlin and Mandy Harcourt -Activities at OU1, 2, 4, 5, 7, & 8

Chairman Gunderson: O&M update, Melody and Mandy Harcourt. Mandy Harcourt: Today's update for ARP will cover activities completed and ongoing since we last met in March. ARP responded to 58 hotline calls, 229 utility locate tickets and conducted 62 site visits between March and June. Libby and Troy property's abatement completed; 276 Dolphin Way, interior. GID 5730, that was the shack out at the fish pond area. GID 10474, carrier around the landfill site in Troy, and then we also conducted a quick response for spill that happened out of the dump in Troy. Libby and Troy property sampling completed; 365 Bobtail Way and 96 Foot Drive. Libby and Troy property upcoming abatements; 713 Michigan Ave is an interior removal of a sub floor, 386 Riverside Drive exterior removal yard areas, 540 Quartz Road. This is a NOPEC that's going to be coming your guys way, one of two. This property is a combo, so it has an interior trigger, the Atticus Bull. However, at that point, the previous owner didn't allow access to the property to conduct further inspection on the yard areas. It's going to be a removal. We're just trying to figure out if it's going to be a combo or not, and the soil samples will be collected before that. The first scope of work you guys are going to be seeing, this is a NOEC, is for approval to cover the cost of the sampling that needs to be done. When the sampling comes back, that will determine whether or not it's going to be a combo or just an interior. Either way, you're going to be getting a second one for the abatement. **Chairman Gunderson:** Okay. Commissioner Teske: Is it changed hands, is it transferred or is it still the same owner? Mandy Harcourt: This one is actually foreclosed on. Commissioner Teske: Okay, all right. Mandy Harcourt: Yeah, and it's owned by a bank and they have a representative here, a realtor or broker I think that is acting as representative for them. However, also just FYI we've been working with a couple of people that are prospective buyers for this property. They're aware of what's going on with the property, but they're also want to do a quick sale on it. It might transition to different owners right in the middle of everything which will make it a little bit messier, but we'll let you know when I'm sending out any documents that by the time you guys get the abatement it might be under a different property name. Chairman Gunderson: What's the possible time frame on that quick sale? Mandy Harcourt: He isn't 100% yet. He's still kind of working with us and wanting to touch base. He has spoken to REMAX the representative for the property, about doing it. He and his wife are leaning towards it but aren't 100% sure yet. I'm not sure how fast a quick sale works like that. I'm guessing they'll probably fall right into the middle of what we're doing. Chairman Gunderson: Right, and that gives me a little better idea. Mandy Harcourt: Moving on with upcoming abatements; 1218 Dakota Ave is an exterior removal, 118 West Kalispell is an interior removal, and we have some stockpiles that Noble has staged at the Port property that came from Asa Wood that need to be removed. Libby and Troy active properties upcoming sampling; that's the 514 Mineral I just talked to you guys about. There's another property that will be coming up for an exterior abatement. It's 558 Quartz. I wanted to present them at the meeting, but I didn't get the bids back in time. They'll be coming through email for your guy's approval. One is gonna be for sampling and one is gonna be for abatement. Commissioner Teske: What was the material spill? Mandy Harcourt: We got a call. Brian called me on a Friday. Someone had gone up there and removed vermiculite insulation from somewhere. They had dumped it into a dumpster, I'm not sure if a can fell out of the back of the truck or something, but there was some in the dumpster, there were some outside of the dumpster, and then there were some piled over here. We went out and took a look at it. They covered it up, blocked it off. ER couldn't get in there to complete it because of the access issue, so we waited until Sunday when the dump was closed. ER went up there, cleaned it all up, emptied out and deconned the green box that they had put it in, did surface scrapes in the area where it had spilled, and put some crush down for cover. Commissioner Teske: No idea who it was? Mandy Harcourt: No. Chairman Gunderson: Senator? Senator Cuffe: Yeah, I think to follow up on that, I'm not sure how, but that's exactly the kind of thing we're set up to try to avoid. Chairman Gunderson: Exactly. Senator Cuffe: Things that you have feared we'd find dump someplace. We should try to make some kind of public announcement or something to avoid that. The other question I had was, was the one on Mineral Avenue, is that the one you said is going in the process of perhaps changing hands? Mandy Harcourt: Yes. Senator Cuffe: I do think on this one. That's the whole thing, a big one. Chairman Gunderson: Yep. And that's exactly it. I guess the question to you, Mandy, is do we need to update how we're advertising or utilizing more public service, you know, PR stuff that doesn't cost us a lot, but gets that message out. Maybe a news article needs to be done in all three papers. Mandy Harcourt: I mean, honestly, I am at my limit for outreach. We do weekly ads in all the papers. We do all of the outreach events. We do Farmers Market here; we do Farmers Market in Troy. We put up posters, we do flyers. I think this is gonna continue to happen. I don't think that a property owner found it and went, oh, I don't know what this is and I'm gonna go dispose of it. I think a property owner was either being lazy or

didn't wanna deal with ARP holding them up or anything. So they went there and they dumped it. I think that's not gonna happen a lot, but I think that it will continue to happen every once in a while. It used to happen a lot more than it does now. We haven't had a situation, a quick response like that for years. I think that it hat is huge. I don't think that it's something that occurs nearly as much as it did. I mean, if you think that is houge. I don't think that it's something that occurs nearly as much as it did. I mean, if you think that we should post more stuff in the paper. I think we do a pretty good job at informing the community that we're here and how to contact us. <b>Chairman Gunderson</b> : Do you think we could actually put a letter to the editor out that the panel could sign on to that hits those points that we keep hammering to everybody so we don't end up with those 50-gallon garbage sacks out in the forest full of asbestos. <b>Senator Cuffe</b> : I think it's time a good idea. <b>Chairman Gunderson</b> : I think it's time to put our names on it and actually formulate something. It doesn't have to be gaudy. Maybe what I'll do is I'll go talk to the editor it's more a public service.
