I. BACKGROUND

A. The Montana Pole and Treating Plant Site (the "Site") is located in Silver Bow County in Butte, Montana. A former wood treating plant owned and operated by members of the Oaas family and Montana Pole and Treating Plant, Inc. ("MPTP"), is located on the Site. The plant operated at the Site from approximately 1946 through 1984. MPTP operations and other MPTP related Site activities resulted in the release of hazardous or deleterious substances including, but not limited to, pentachlorophenol ("PCP") and PCP contaminated wood treating oil, into surface and subsurface soils, surface water and ground water at the Site.

B. The United States of America ("United States") asserts that, between 1983 and 1993, in response to a release or substantial threat of release of hazardous substances at or from the Site, the United States Environmental Protection Agency ("EPA") conducted a series of response actions at the Site pursuant to Section 104 of the Comprehensive Environmental Response, Compensation, and Liability Act, as amended ("CERCLA"), 42 U.S.C. § 9604, and EPA's removal authority. These actions included, but are not limited to, the excavation and storage of contaminated soils; fencing; construction of groundwater interception, recovery, and treatment systems; and various engineering studies. The United States asserts that EPA contracted with Roy F. Weston, Incorporated ("Weston") and Riedel Environmental Services, Inc. ("Riedel") to assist EPA in

2 performing some of these response activities, and Weston and
3 Riedel, under the direction and control of EPA, provided these
4 services as response action contractors pursuant to Section 119
5 of CERCLA, 42 U.S.C. § 9619, and in accordance with the National
6 Contingency Plan ("NCP"), 40 C.F.R. Part 300. The United States
7 has estimated that total costs for these response actions
8 conducted by the United States, together with the costs of
9 oversight of the Remedial Investigation and Feasibility Study for
10 the Site ("RI/FS") and other costs through the completion of
11 Remedial Design, will be \$11,778,000.00.

12 C. Pursuant to Section 105 of CERCLA, 42 U.S.C. § 9605, the
13 Site was listed on the National Priorities List, set forth at 40
14 C.F.R. Part 300, Appendix B, by publication in the Federal
15 Register on July 22, 1987 (52 Fed. Reg. 27623).

16 D. The United States alleges that in response to a release
17 or a substantial threat of release of hazardous substances at or
18 from the Site, Atlantic Richfield Company ("ARCO"), under an
19 Administrative Order on Consent ("AOC") issued by the State of
20 Montana ("State") Department of Health and Environmental Sciences
21 in 1990, conducted an RI/FS for the Site. The 1993 Record of
22 Decision for the Site states that the RI/FS was performed in
23 accordance with the NCP.

24 E. The State acknowledges that ARCO paid \$69,000.00 to the
25 State to perform natural resource damage assessment activities
26 pursuant to Article XXII of the RI/FS AOC, and ARCO also

2 reimbursed the State \$23,000.00 pursuant to Article XXI of the
3 RI/FS AOC for past response costs incurred by the State up to the
4 date of the RI/FS AOC. ARCO has reported that its estimate of
5 the cost of the RI/FS to ARCO was approximately \$5.5 million.

6 F. The United States, on behalf of EPA, filed a complaint
7 in this matter styled as United States v. MPTP, et al. (CV 91-
8 082-BU-PGH) alleging causes of action pursuant to Sections 107
9 and 113(g)(2) of CERCLA, 42 U.S.C. §§ 9607 and 9613(g)(2),
10 against MPTP, Torger L. Oaas, ARCO, and Burlington Northern
11 Railroad Company ("BNRR") on October 9, 1991. The United States
12 alleged that MPTP and Torger L. Oaas were past and present owners
13 and operators of the Site, and alleged that ARCO and BNRR were
14 past and/or present owners of portions of the Site. On October
15 24, 1991, technical amendments were made in the United States'
16 First Amended Complaint. On May 25, 1993, the United States, by
17 a Second Amended Complaint, added Inland Properties, Inc. as a
18 defendant in the foregoing action and alleged that Inland
19 Properties, Inc. is a present owner of a portion of the Site.

20 G. The United States in its complaint, as amended, seeks
21 reimbursement of response costs incurred and to be incurred by
22 the United States for response actions in connection with the
23 release or threatened release of hazardous substances, and a
24 declaration of the named defendants' liability for further
25 response costs at the Site. In its answer to the First Amended
26

1 Complaint of the United States dated November 22, 1991, ARCO
2 asserted a claim in recoupment against the United States.
3 H. On October 25, 1990, ARCO filed a complaint in this
4 Court captioned as ARCO v. Oaas, et al. (CV 90-75-BU-PGH),
5 against MPTP, Torger L. Oaas, T. Eric Oaas, Martha Oaas, and Bank
6 of Montana-Butte which was later amended to add BNRR, Weston,
7 and Riedel as defendants. In response to cross-claims made by
8 Dennis R. Washington, Montana Resources, Inc., and Inland
9 Properties, Inc. (collectively "MRI"), ARCO also filed
10 counter-claims against MRI on September 10, 1992. ARCO alleged,
11 inter alia, that all of these parties are liable to ARCO under
12 Sections 107 and 113 of CERCLA, 42 U.S.C. §§ 9607 and 9613, and
13 the Montana Comprehensive Environmental Cleanup and
14 Responsibility Act ("CECRA"), Mont. Code Ann. §§ 75-10-701
15 et seq., for contribution and for recovery of response costs in
16 connection with the release or threatened release of hazardous or
17 deleterious substances at the Site and for contribution for
18 natural resource damages under CERCLA and CECRA. In addition,
19 ARCO asserted common law negligence claims against Riedel and
20 Weston, and asserted a contractual indemnity claim against MRI.
21 I. BNRR filed cross-claims against MPTP, Torger L. Oaas,
22 T. Eric Oaas, Martha Oaas, Weston, and Riedel, and cross-claims
23 and counterclaims against ARCO. On May 15, 1992, BNRR brought a
24 third party complaint against MRI. On October 24, 1994, BNRR
25 moved to amend its pleadings to assert third-party claims against

2 Bud King Construction Company, the State, State Department of
3 Transportation, and State Highway Commission. BNRR alleged,
4 inter alia, that all of these parties are liable to BNRR for cost
5 recovery and contribution under Sections 107 and 113 of CERCLA,
6 42 U.S.C. §§ 9607 and 9613, CECRA, Mont. Code Ann. §§ 75-10-701
7 et seq., and common law in connection with the release or
8 threatened release of hazardous or deleterious substances at the
9 Site and for contribution for natural resource damages under
10 CERCLA and CECRA.

11 J. On April 7, 1992, the Court ordered ARCO v. Oaas, et
12 al. and United States v. MPTP, et al. consolidated for all
13 purposes ("Consolidated Litigation").

14 K. On August 18, 1992, MRI filed cross-claims in this
15 matter against MPTP, Torger L. Oaas, T. Eric Oaas, Martha Oaas,
16 ARCO, Weston, and Riedel, and counterclaims against BNRR
17 alleging, inter alia, that all of these parties are liable to MRI
18 under Sections 107 and 113 of CERCLA, 42 U.S.C. §§ 9607 and 9613,
19 and CECRA, Mont. Code Ann. §§ 75-10-701 et seq., for contribution
20 and for recovery of response costs in connection with the release
21 or threatened release of hazardous or deleterious substances at
22 the Site and for contribution for natural resource damages under
23 CERCLA and CECRA. In its Answers, Counterclaims, and Cross-
24 claims, MRI asserted a "Notice of Reservation of Cross-claims".
25 On May 17, 1995, MRI moved to amend its pleadings to include
26 additional claims it may have against ARCO, including claims

based on contract. ARCO has opposed this motion on procedural and substantive grounds, and contests MRI's ability or right to bring any additional claims in this action. The Court has not ruled on this motion.

L. On January 21, 1992, Riedel filed a counterclaim alleging that ARCO is liable under CERCLA, CECRA and common law for contribution to Riedel in connection with the release or threatened release of hazardous or deleterious substances at the Site.

M. On January 21, 1992, Weston filed a counterclaim alleging that ARCO is liable under CERCLA, CECRA and common law for contribution to Weston in connection with the release or threatened release of hazardous or deleterious substances at the Site and that ARCO is liable to Weston under the theories of recoupment and set-off.

N. The Public Comment Drafts of the RI Report and FS for the Site were completed in February 1993.

O. Pursuant to Section 117 of CERCLA, 42 U.S.C. § 9617, the State, as the lead agency, published notice of the completion of the RI and FS and of the proposed plan for remedial action for the Site on May 7, 1993, in a major local newspaper of general circulation. The State provided an opportunity for written and oral comments from the public on the proposed plan and the supporting analysis and information in the administrative record. The transcript of the public hearing held on May 27, 1993, and

1 the written public comments are available to the public as part
2 of the administrative record upon which the selection of the
3 response action was based.

4 P. The EPA and State decision on the remedial action to be
5 implemented at the Site is set forth in a final record of
6 decision, executed by the State on September 21, 1993 and by EPA
7 on September 22, 1993. The 1993 Record of Decision includes a
8 responsiveness summary to the public comments received. The
9 present value of the cost to perform the remedy, as estimated in
10 the 1993 Record of Decision, ranges from \$27,500,000.00 to
11 \$55,200,000.00. The EPA's and State's estimate of the cost to
12 perform the remedy as set forth in the 1993 Record of Decision is
13 approximately \$35,300,000.00, as shown in Appendix A attached
14 hereto. Notice of the final remedial action plan, as set forth
15 in the 1993 Record of Decision, was published in accordance with
16 Section 117(b) of CERCLA, 42 U.S.C. § 9617(b), on October 10,
17 1993.

18 Q. In accordance with the NCP, EPA requested in June 1994
19 that the State undertake the implementation of the Remedial
20 Design for the Site. Upon such notice, EPA entered into a
21 cooperative agreement with the State under which the State, using
22 EPA funding, is implementing the Remedial Design. EPA and the
23 State anticipate entering into a similar agreement to implement
24 the Remedial Action and provide for Operation and Maintenance of
25 the remedy at the Site. In accordance with Section 121(f)(1)(F)
26

1 of CERCLA, 42 U.S.C. § 9621(f) (1) (F), and for other reasons, the
2 State was also given the opportunity to participate in the
3 settlement discussions which led to this Consent Decree.

4 R. The United States will file an amended complaint, prior
5 to the lodging of this Consent Decree with the Court, modifying
6 its complaint against Inland Properties, Inc., to include the
7 same claims against Dennis R. Washington, personally, and Montana
8 Resources, Inc. The State will file, prior to the Court's
9 approval and entry of this Consent Decree, a complaint which
10 alleges the State's claims against the Settling Defendants for
11 Past and Future Response Costs as costs of remedial action under
12 Sections 107 and 113(g) (2) of CERCLA, 42 U.S.C. §§ 9607 and
13 9613(g) (2), and as remedial action costs under Section 715 of
14 CECRA, Mont. Code Ann. § 75-10-715.

15 S. In accordance with Section 122(j) (1) of CERCLA, 42
16 U.S.C. § 9622(j) (1), EPA notified the relevant Federal natural
17 resource trustee, the United States Department of the Interior
18 ("DOI"), on May 24, 1991 of negotiations with potentially
19 responsible parties regarding the release of hazardous substances
20 that may have resulted in injury to the natural resources under
21 Federal trusteeship. The DOI chose not to participate in
22 discussions relating to natural resource damages at the Site.

23 T. This Consent Decree does not address potential claims of
24 the natural resource damage trustee of the United States for
25 natural resource damages as no such claims have been brought by
26

1 the United States in either the first or second amended
2 complaints filed in this Consolidated Litigation.

3 U. The objectives of the Parties in entering into this
4 Consent Decree are: (1) the resolution as provided in this
5 Consent Decree of liability of the Parties associated with Past
6 and Future Response costs and past and future response and
7 remedial action(s) regarding the Site; (2) the implementation of
8 the Remedial Design, Remedial Action and Operation and
9 Maintenance at the Site in a cost-effective and timely manner;
10 (3) the resolution as provided in this Consent Decree of
11 liability among the Settling Parties regarding the Site; (4) the
12 resolution as provided in this Consent Decree of liability of the
13 Settling Parties for the migration of any hazardous or
14 deleterious substances consisting of pentachlorophenol, PAHs,
15 TPHs, BTEX, dioxins, furans, or related constituents from the
16 MPTP operations; and (5) the resolution as provided in this
17 Consent Decree of liability of the Parties associated with the
18 alleged releases or threatened releases of Waste Material at, on,
19 or from the Site.

20 V. The Court, by approving the entry of this Consent
21 Decree, finds that this Consent Decree has been negotiated by the
22 Parties in good faith, that implementation of this Consent Decree
23 will expedite the cleanup of the Site and will avoid prolonged
24 and complicated litigation between the Parties, and that this
25 Consent Decree is fair, reasonable, and in the public interest.

1 **THEREFORE, it is hereby ORDERED, ADJUDGED, AND DECREED:**

2 **II. JURISDICTION**

3 1. This Court has jurisdiction over the subject matter of
4 this action pursuant to 28 U.S.C. §§ 1331 and 1345, and 42 U.S.C.
5 §§ 9606, 9607 and 9613(b) and supplemental jurisdiction over the
6 claims arising under the laws of the State. This Court also has
7 personal jurisdiction over the Parties. Solely for the purposes
8 of this Consent Decree, the Parties waive all objections and
9 defenses that they may have to jurisdiction of the Court or to
10 venue in the District of Montana. The Parties shall not
11 challenge the terms of this Consent Decree or this Court's
12 jurisdiction to enter and enforce this Consent Decree.

13 **III. NO ADMISSION OF LIABILITY**

14 2. The Parties that have entered into this Consent Decree
15 do not admit any liability arising out of the transactions or
16 occurrences alleged in the complaints, counterclaims or cross-
17 claims filed in the Consolidated Litigation; nor do the Settling
18 Parties acknowledge that the release or threatened release of
19 hazardous or deleterious substances at or from the Site
20 constitutes an imminent and substantial endangerment to the
21 public health or welfare or the environment. The Settling
22 Parties do not admit and retain the right to controvert any of
23 the factual or legal statements made in any pleadings filed in
24 the Consolidated Litigation in any judicial or administrative
25 proceeding. This Consent Decree, any factual or legal statements

1 made in this Consent Decree, and the resulting obligations of the
2 Parties shall not be admissible in any judicial or administrative
3 proceeding against any Party, over its objection, as evidence of
4 liability or as an admission of any factual or legal statements
5 or determinations made herein, but it shall be admissible in an
6 action to modify or enforce this Consent Decree. This Consent
7 Decree shall not be admissible in any judicial or administrative
8 proceeding brought by or on behalf of any natural resource
9 trustee or any Party to this Consent Decree for natural resource
10 damages as evidence of liability or as an admission of any
11 factual or legal statements or determinations made herein.

12 **IV. PARTIES BOUND**

13 3. This Consent Decree applies to and is binding upon the
14 United States and the State, and upon the Settling Parties and
15 their successors and assigns. Any change in ownership or
16 corporate or other legal status including, but not limited to,
17 any transfer of assets or real or personal property, shall in no
18 way alter the responsibilities of the Settling Parties under this
19 Consent Decree.

20 **V. DEFINITIONS**

21 4. Unless otherwise expressly provided herein, terms used
22 in this Consent Decree which are defined in CERCLA or in
23 regulations promulgated under CERCLA shall have the meaning
24 assigned to them in CERCLA or in such regulations. Whenever
25

1 terms listed below are used in this Consent Decree or in any
2 appendix attached hereto the following definitions shall apply:

3 a. "ARCO" shall mean the Atlantic Richfield Company, a
4 Delaware corporation, and its predecessors.

5 b. "BNRR" shall mean the Burlington Northern Railroad
6 Company, a Delaware corporation, and its predecessors.

7 c. "CECRA" shall mean the Montana Comprehensive
8 Environmental Cleanup and Responsibility Act, as amended, Mont.
9 Code Ann. §§ 75-10-701 et seq.

10 d. "CERCLA" shall mean the Comprehensive Environmental
11 Response, Compensation, and Liability Act of 1980, as amended, 42
12 U.S.C. §§ 9601 et seq.

13 e. "Certification of Completion" shall mean EPA's
14 certification pursuant to Section 122(f)(3) of CERCLA, 42 U.S.C.
15 § 9622(f)(3), that Remedial Action has been completed at the Site
16 in accordance with the requirements of CERCLA, the NCP and the
17 ROD.

18 f. "Consent Decree" shall mean this Decree and any
19 attached appendices. In the event of any conflict between this
20 Consent Decree and any Appendix, this Decree shall control.

21 g. "Day" shall mean a calendar day. "Working day" shall
22 mean every day other than a Saturday, Sunday, or State or Federal
23 holiday. In computing any period of time under this Consent
24 Decree, where the last day would fall on a Saturday, Sunday, or

1 State or Federal holiday, the period shall run until the Settling
2 Defendant's close of business of the next working day.

3 h. "DEQ" shall mean the Montana Department of
4 Environmental Quality, formerly known as the Montana Department
5 of Health and Environmental Sciences ("DHES"), and any successor
6 departments or agencies of the State.

7 i. "Effective Date" shall mean the date upon which this
8 Consent Decree is entered by the Court.

9 j. "EPA" shall mean the United States Environmental
10 Protection Agency and any successor departments or agencies of
11 the United States.

12 k. "Future Response Costs" shall mean all costs, not
13 inconsistent with the NCP, including, but not limited to, direct
14 and indirect costs, that the State, EPA and the United States
15 have incurred or will incur which relate to response actions at
16 the Site in implementing the Remedial Action and Operation and
17 Maintenance.

18 l. "Interest," in accordance with 42 U.S.C. § 9607(a),
19 shall mean interest at the rate specified for interest on
20 investments of the Hazardous Substance Superfund established
21 pursuant to the Internal Revenue Code, 26 U.S.C. § 9507. In
22 calculating the Interest, EPA compounds on an annual basis.

23 m. "MRI" shall collectively refer to and mean Inland
24 Properties, Inc., a Montana corporation; Montana Resources, Inc.,
25

1 a Montana corporation; and Dennis R. Washington, and their
2 predecessors.

3 n. "National Contingency Plan" or "NCP" shall mean the
4 National Oil and Hazardous Substances Pollution Contingency Plan
5 promulgated pursuant to Section 105 of CERCLA, 42 U.S.C. § 9605,
6 codified at 40 C.F.R. Part 300, and any amendments thereto.

7 o. "Operation and Maintenance" or "O&M" shall mean all
8 activities required to maintain the effectiveness of the Remedial
9 Action as required under the Operation and Maintenance Plan to be
10 developed for the Site.

11 p. "Paragraph" shall mean a portion of this Consent Decree
12 identified by an arabic numeral or an upper or lower case letter.

13 q. "Parties" shall mean the United States, the State,
14 Weston, Riedel, ARCO, BNRR, and MRI.

15 r. "Past Response Costs" shall mean all costs, not
16 inconsistent with the NCP, including, but not limited to, direct
17 and indirect costs, that the United States and the State have
18 paid or will pay for response actions, including Remedial Design,
19 undertaken at the Site prior to implementing the Remedial Action
20 and Operation and Maintenance, together with accrued interest on
21 all such costs.

22 s. "RCRA" shall mean the Solid Waste Disposal Act, as
23 amended, 42 U.S.C. §§ 6901 et seq. (also known as the Resource
24 Conservation and Recovery Act).

25

1 t. "Record of Decision" or "ROD" shall mean the EPA/State
2 Record of Decision in which the final remedial action plan
3 relating to the Site is set forth, as executed by the State on
4 September 21, 1993, and by the Regional Administrator, EPA Region
5 VIII, on September 22, 1993, and attached hereto as Appendix B,
6 all attachments thereto, and any subsequent modifications
7 thereof. The "1993 Record of Decision" shall mean the EPA/State
8 Record of Decision in which the final remedial action plan
9 relating to the Site is set forth, as executed by the State on
10 September 21, 1993, and by the Regional Administrator, EPA Region
11 VIII, on September 22, 1993, attached hereto as Appendix B, and
12 all attachments thereto, only.

13 u. "Remedial Action" shall mean the response actions at
14 the Site set forth in the Record of Decision, except for O&M.

15 v. "Remedial Design" shall mean the response actions at
16 the Site to design the Remedial Action.

21 y. "Settlement Account" shall mean the State special
22 revenue account related to the Site into which any payments are
23 made as provided in Section IX of the Consent Decree.

1 z. "Settling Defendants" shall mean ARCO, BNRR, and MRI,
2 and their successors and assigns to the extent the successor's
3 and assign's liability at this Site derives from the liability of

6 aa. "Settling Parties" shall mean ARCO, BNRR, MRI, Riedel,
7 and Weston.

8 ab. "Site" shall mean the Montana Pole and Treating Plant
9 Superfund site, encompassing approximately 45 acres, located in
10 Silver Bow County in Butte, Montana, generally depicted and
11 described in Appendix C to this Consent Decree, and shall include
12 any area where hazardous or deleterious substances consisting of
13 pentachlorophenol, PAHs, THPs, BTEX, dioxins, furans, or related
14 constituents, from the MPTP operations, have been deposited,
15 stored, disposed of, placed, or are otherwise located or come to

12 VI. REIMBURSEMENT OF RESPONSE COSTS

13 5. Payment of Past Response Costs to the United
14 States. Within thirty (30) days of the Effective Date of this
15 Consent Decree, ARCO, BNRR and MRI shall pay, in full and final
16 satisfaction of Past Response Costs, to the United States for
17 deposit to the Hazardous Substance Superfund a total of Two
18 Million, Seven Hundred Thousand Dollars (\$ 2,700,000.00) as
19 follows:

20 a. ARCO shall be responsible for reimbursing the United
21 States for Past Response Costs in the amount of
22 \$1,989,630.00;

1 b. ENRR shall be responsible for reimbursing the United

10 USAO file number 95Z0291/001, EPA Region VIII, Site/Spill ID #
11 69, and the Department of Justice case number 90-11-2-429.
12 Payment shall be made in accordance with instructions provided to
13 the Settling Defendants by the United States Attorney for the
14 District of Montana before execution of the Consent Decree by the
15 Settling Defendants. Any EFTs received by the New York Federal
16 Reserve Bank after 4:00 p.m. (Eastern Time) will be credited to
17 the next working day. Settling Defendants shall send notice that
18 such payment has been made to the United States as specified in
19 Section XXII (Notices and Submissions) and the Financial
20 Management Officer, EPA Region VIII, Office of Technical and
21 Management Services, 999 18th Street, Denver, CO 80202. Failure
22 to provide such notice shall not subject the Settling Defendants
23 to stipulated penalties under Paragraph 25 of this Consent
24 Decree.

1 7. Payment of Future Response Costs to the United States
2 and the State. Each of the Settling Defendants is responsible
3 for the following respective percentage shares of required
4 payments under the terms of this Consent Decree: ARCO-73.69% of
5 required payments; BNRR- 21.05% of required payments; and, MRI-
6 5.26% of required payments.

7 a. Settling Defendants shall pay, subject to the reopener
8 provisions in Paragraphs 10, 29, and 30, their respective shares
9 in satisfaction of Future Response Costs at the Site, Thirty Five
10 Million Seventy Thousand Dollars (\$35,070,000.00) to the United
11 States and the State as provided herein to the Settlement Account
12 to be established and maintained pursuant to the terms of Section
13 IX (Settlement Account) of this Consent Decree.

14 b. The sum of \$35,070,000.00 described in this Section, and
15 due and owing the United States and the State, shall be paid by
16 the Settling Defendants pursuant to the respective percentage
17 shares set forth in this Paragraph 7 by payment to the Settlement
18 Account as follows:

19 (i) on or before August 1, 1996, ARCO shall pay the sum of
20 Fourteen Million Five Hundred Sixty Eight Thousand Five Hundred
21 Thirteen Dollars (\$14,568,513.00) without interest; (ii) on or

6 or before August 1, 1997, MRI shall pay the sum of Five Hundred
7 Twenty Six Thousand Dollars (\$526,000.00) with interest on said

9 2, 1996 through August 1, 1997; (ix) on or before August 1, 1998,
10 or three years from the date of entry of this Consent Decree,
11 whichever date is later, MRI shall pay the sum of Two Hundred

13 with interest on said sum at the rate of 7% compounded annually

24 provisions by the United States or the State, and after adequate
25 provision for future obligations of the State with respect to the
26 Site, as determined by EPA and the State, funds remain in the

1 Settlement Account, the funds shall be transferred to the
2 Hazardous Substance Superfund or to the United States in a manner
3 to be specified by EPA, up to the amount of unreimbursed Past
4 Response Costs for the Site. EPA and the State's determination
5 under this Paragraph is not subject to challenge by the Settling
6 Defendants or to the Dispute Resolution procedures in Section
7 VIII.

8 8. Obligation for Payment of Response Costs. The respective
9 obligations of ARCO, BNRR and MRI to pay the amounts referenced
10 in Paragraph 7, above, to the United States and the State, and
11 the other obligations set forth in Sections VI (Reimbursement of
12 Response Costs) and VII (Additional Response Cost Reopener) are
13 solely the respective and individual responsibility of ARCO, BNRR
14 or MRI and are not a joint and several liability or obligation.

15 9. Payment of any money by the Settling Defendants for Past
16 Response Costs or Future Response Costs under this Consent Decree
17 is not a fine, penalty or monetary sanction.

18 VII. ADDITIONAL RESPONSE COST REOPENER

19 10. a. For the purposes of this Section VII, the term
20 "Cost Reopener Amount" shall mean the greater of either a) the
21 sum of the payments made by Settling Defendants into the
22 Settlement Account plus net earnings of the Settlement Account
23 plus \$6,000,000.00 or b) \$41,300,000.00, provided the Settling
24 Defendants make the payments set forth in Paragraph 7. Except as
25 provided in Paragraphs 26, 29, 30 and 40, the Settling Defendants

2 shall not be responsible for Future Response Costs in addition to
3 those paid by the Settling Defendants pursuant to Paragraph 7 of
4 this Consent Decree, unless the Future Response Costs exceed the
5 "Cost Reopener Amount." If demanded by the United States and the
6 State, as set forth in this Paragraph 10, the Settling Defendants
7 shall be individually responsible for their respective percentage
8 shares, as set forth in Paragraph 7, of the amount of Future
9 Response Costs which exceed the "Cost Reopener Amount." Such
10 exceedance, if any, shall be the total actual Remedial Action
11 costs and actual and/or estimated Operation and Maintenance costs
12 for the final remedial action plan, minus the "Cost Reopener
13 Amount."

14 b. The United States and the State shall present a
15 demand to the Settling Defendants for the exceedance of the "Cost
16 Reopener Amount." The United States' and the State's demand
17 shall include specific instructions for payment of the demanded
18 funds and shall contain the payment amounts sought by the United
19 States and the State from ARCO, BNRR, and MRI, and an accounting
20 of the expenditure of all costs incurred to date by the United
21 States and the State in implementing the Remedial Action and O&M,
22 sufficient to enable the Settling Defendants to evaluate the
23 expenditures to determine whether those expenditures were
24 consistent with CERCLA, CECRA, the NCP, and the ROD remedy. The
25 accounting shall include supporting documentation including a
26 standard cost package for EPA's costs which consists of: (1)

1 payroll information, including the SCORE report or an equivalent
2 cost summary and all timesheets; (2) travel information, which
3 includes a SCORE report or an equivalent cost summary, travel
4 authorizations, travel vouchers, and required receipts; (3) EPA
5 contractor data, including site specific vouchers and progress
6 reports, and the SCORE report or an equivalent cost summary; (4)
7 EPA Interagency Agreements ("IAGs"), including SCORE reports or
8 an equivalent cost summary, IAG agreements and any amendments
9 thereto, and progress reports, if any; and (5) EPA Cooperative
10 Agreements, including SCORE reports or an equivalent cost
11 summary, cooperative agreements and any amendments thereto,
12 drawdown documentation, and State quarterly and State contractor
13 monthly progress reports. The accounting of the costs incurred
14 by the State shall itemize the State costs, and shall include, at
15 a minimum, the following information: the names and titles of
16 State employees and retained legal counsel, date(s), time and
17 other direct charges; indirect charges; and State contractor
18 vouchers and/or invoices for work performed for State activities
19 incurred in implementing the Remedial Action and O&M. The
20 demand, accounting and the supporting documentation shall be
21 included in the record for the Site maintained by EPA and the
22 State.

23 c. The Settling Defendants shall pay the exceedence of
24 the "Cost Reopener Amount" in accordance with their respective
25 percentage shares as set forth in Paragraph 7, as demanded by the
26

1 United States and the State. Within 120 days after receipt of
2 the demand, each Settling Defendant will pay or dispute the sum
3 demanded of it. However, if the United States and the State have
4 not yet actually incurred expenses in excess of the Cost Reopener
5 Amount, each Settling Defendant shall, within 120 days of demand,
6 either dispute or agree to pay the Settling Defendant's
7 respective share of the requested sum, and the obligation to
8 submit payment shall be tolled until the Cost Reopener Amount has
9 actually been exceeded. Failure to dispute the payment of such
10 sums within the allotted time shall be deemed an agreement to pay
11 such sums. In the event a demand is presented under this Section
12 and is disputed by the Settling Defendant(s), Settling
13 Defendant(s) reserve all rights to challenge this demand, as
14 provided in Paragraph 33 h. of this Consent Decree.

15 **VIII. DISPUTE RESOLUTION**

16 11. Unless otherwise expressly provided for in this Consent
17 Decree, the dispute resolution procedures of this Section shall
18 be the exclusive mechanism to resolve disputes between the
19 Settling Defendants and the United States or the State arising
20 under or with respect to this Consent Decree. However, the
21 procedures set forth in this Section shall not apply to actions
22 by the United States and the State to enforce obligations of the
23 Settling Defendants that have not been disputed in accordance
24 with this Section.

25

1 12. Any dispute which arises under or with respect to this
2 Consent Decree shall in the first instance be the subject of
3 informal negotiations between the parties to the dispute. The
4 period for informal negotiations shall not exceed twenty (20)
5 days from the time the dispute arises, unless it is modified by
6 written agreement of the parties to the dispute. The dispute
7 shall be considered to have arisen when one party to the dispute
8 sends the other parties to the dispute a written Notice of
9 Dispute.

10 13. a. In the event that the parties to the dispute cannot
11 resolve a dispute by informal negotiations under the preceding
12 Paragraph, then the position advanced by EPA and the State shall
13 be considered binding unless, within thirty (30) days after the
14 conclusion of the informal negotiation period, the Settling
15 Defendant(s) invoke(s) the formal dispute resolution procedures
16 of this Section by serving on the United States and the State a
17 written Statement of Position on the matter in dispute,
18 including, but not limited to, any factual data, analysis or
19 opinion supporting that position and any supporting documentation
20 relied upon by the Settling Defendant(s). The Statement of
21 Position shall specify the Settling Defendant's position as to
22 whether formal dispute resolution should proceed under Paragraph
23 14 or 15.

24 b. Within twenty-one (21) days after receipt of
25 Settling Defendants' Statement of Position, EPA and the State
26

1 will serve on Settling Defendants a Statement of Position,
2 including, but not limited to, any factual data, analysis, or
3 opinion supporting that position and all supporting documentation
4 relied upon by EPA and the State. This Statement of Position
5 shall include a statement as to whether formal dispute resolution
6 should proceed under Paragraph 14 or 15. Within fourteen (14)
7 days after receipt of EPA's and the State's Statement of
8 Position, Settling Defendant(s) may submit a reply.

9 c. If there is disagreement as to whether dispute
10 resolution should proceed under Paragraph 14 or 15, the parties
11 to the dispute shall follow the procedures set forth in the
12 paragraph determined by EPA to be applicable. However, if the
13 Settling Defendants ultimately appeal to the Court to resolve the
14 dispute, the Court shall determine which paragraph is applicable
15 in accordance with the standards of applicability set forth in
16 Paragraphs 14 and 15.

17 14. Formal dispute resolution for disputes that are accorded
18 review on the administrative record under CERCLA or applicable
19 principles of administrative law shall be conducted pursuant to
20 the procedures set forth in this Paragraph. Nothing in this
21 Section shall be construed to allow any dispute by Settling
22 Defendants regarding the validity of the ROD's provisions, except
23 as provided in Paragraph 33 h.

24 a. An administrative record of the dispute shall be
25 maintained by EPA and shall contain all statements of position,
26 including supporting documentation, submitted pursuant to this
27

1 Section, and in the event of a dispute regarding reopeners under
2 Sections XII (Pre-Certification Reservations) and XIII (Post-
3 Certification Reservations), EPA and State records regarding
4 information and conditions known under Paragraph 31 shall be
5 deemed included in the administrative record for the dispute.
6 Where appropriate, EPA may allow submission of supplemental
7 statements of position by the parties to the dispute.

8 b. The Assistant Regional Administrator for Ecosystems
9 Protection and Remediation ("ARA"), EPA Region VIII, or his
10 successor, will issue a final administrative decision resolving
11 the dispute based on the administrative record described in
12 Paragraph 14 a. This decision shall be binding upon the Settling
13 Defendants, subject only to the right to seek judicial review
14 pursuant to Paragraphs 14 c. and d.

15 c. Any administrative decision made by EPA pursuant to
16 Paragraph 14 b. shall be reviewable by this Court, provided that
17 a motion for judicial review is filed by the Settling
18 Defendant(s) with the Court and served on all Parties within
19 twenty (20) days of receipt of EPA's decision. The motion shall
20 include a description of the matter in dispute, the efforts made
21 by the Parties to resolve it, the relief requested, and the
22 schedule, if any, within which the dispute must be resolved to
23 ensure orderly implementation of this Consent Decree. The United
24 States and/or the State may file a response to Settling
25 Defendants' motion within twenty (20) days of the receipt of the
26 motion.

27

1 d. In proceedings on any dispute governed by this
2 Paragraph, Settling Defendants shall have the burden of
3 demonstrating that the decision of the ARA is arbitrary and
4 capricious or otherwise not in accordance with law. Judicial
5 review of EPA's decision shall be on the administrative record
6 compiled pursuant to Paragraph 14 a.

7 15. Formal dispute resolution for disputes that are not
8 otherwise accorded review on the administrative record under
9 CERCLA or applicable principles of administrative law, shall be
10 governed by this Paragraph. Following receipt of Settling
11 Defendant(s') Statement of Position submitted pursuant to
12 Paragraph 13, the ARA, EPA Region VIII, or his successor, will
13 issue a final decision resolving the dispute. The ARA's decision
14 shall be binding on the Settling Defendants unless, within twenty
15 (20) days of receipt of the decision, the Settling Defendants
16 file with the Court and serve on the Parties a motion for
17 judicial review of the decision setting forth the matter in
18 dispute, the efforts made by the Parties to resolve it, the
19 relief requested, and the schedule, if any, within which the
20 dispute must be resolved to ensure orderly implementation of the
21 Consent Decree. The United States and/or the State may file a
22 response to Settling Defendants' motion within twenty (20) days
23 of the receipt of the motion.

24

1 16. The invocation of formal dispute resolution procedures
2 under this Section shall not extend, postpone or affect in any
3 way any obligation of the Settling Defendants under this Consent
4 Decree not directly in dispute, unless EPA and the State or the
5 Court agree otherwise. Stipulated penalties as provided for in
6 Paragraph 25 with respect to the disputed matter shall continue
7 to accrue but payment shall be stayed pending resolution of the
8 dispute. Notwithstanding the stay of payment, stipulated
9 penalties shall accrue from the first day of noncompliance with
10 any applicable provision of this Consent Decree. In the event
11 that the Settling Defendants do not prevail on the disputed
12 issue, stipulated penalties shall be assessed and paid as
13 provided in Paragraphs 25 through 27.

14 17. As to any disputes solely between or among the Settling
15 Parties arising under or with respect to this Consent Decree, the
16 party or parties to the dispute may file with the Court and serve
17 upon the United States, State and Settling Parties, a motion for
18 judicial review of the dispute setting forth the matter in
19 dispute, the efforts made by the Parties to resolve it, the
20 relief requested, and the schedule, if any, within which the
21 dispute must be resolved to ensure orderly implementation of the
22 Consent Decree.

23 IX. SETTLEMENT ACCOUNT

24 18. All payments made by Settling Defendants described in
25 Paragraph 7 shall be paid to the United States and the State by
26

1 deposit into a State special revenue account as provided for in
2 Mont. Code Ann. § 17-2-102(1)(a)(ii)(A), which shall be held and
3 maintained by the State in accordance with the requirements of
4 this Consent Decree (the "Settlement Account"). Payments shall
5 be made by EFT to First Bank Montana, Helena Branch, Bank Routing
6 No. 092900383, State Treasurer Account No. 15604100221,
7 specifying in the addendum, third party record, or similar
8 information field "DEQ/MT Pole;To:ADMIN/CENT.SERV." The party
9 making the payment is to contact the "Administrator, Centralized
10 Services Division," DEQ (telephone: (406) 444-2442), at least 48
11 hours prior to initiating the wire transfer to provide notice of
12 the date, time, and amount of the expected transfer and to
13 confirm the wiring instructions, bank routing, and account
14 numbers. Failure to provide such notice shall not subject the
15 Settling Defendants to stipulated penalties under Paragraph 25 of
16 this Consent Decree. Transfers received at the depository
17 institution after 2:00 p.m. Mountain Time will be credited to the
18 next working day.

19 19. The Settlement Account shall be an interest bearing
20 account, and all interest and earnings shall be paid into the
21 Settlement Account and shall be used in the same manner and for
22 the same purposes as the other funds in the Settlement Account.

23 20. Funds in the Settlement Account, including earnings,
24 shall be used by the State, together with EPA, for the purpose of
25 paying Future Response Costs at the Site and for no other
26

1 purpose. For the purposes of Mont. Code Ann. § 17-2-111, or any
2 similar provision of law, no portion of the Settlement Account is
3 to be treated as State general fund money, nor is any portion to
4 be converted or transferred to the State general fund.

5 21. DEQ shall arrange for the investment of funds in the
6 Settlement Account by executing an Investment Agreement with the
7 Montana State Board of Investments. The State and the United
8 States shall bear any and all risk of loss of any and all funds
9 in the Settlement Account resulting from any decrease in the
10 corpus of the investment funds or fluctuations in the rate of
11 return on the investment of such funds. The State Board of
12 Investments shall be entitled to fees, to be deducted from the
13 interest and earnings paid on the Settlement Account, in
14 accordance with the Board's standard policy on fees for
15 investments managed by the Board.

16 22. DEQ shall provide quarterly statements to EPA and the
17 Settling Defendants reporting on the funds received into and
18 disbursed from the Settlement Account, including administrative
19 fees and expenses, and the balance in the account as of the date
20 of the statement. The quarterly statements should also specify
21 the interest rate, interest earnings and the time period during
22 which interest was earned.

23 23. Except as provided in Paragraph 33 h., Settling
24 Defendants and their agents cannot contest or object to the
25 disbursements described above and such disbursements are not
26

1 subject to the Dispute Resolution procedures described in Section
2 VIII or otherwise subject to judicial review.

3 X. FAILURE TO MAKE TIMELY PAYMENTS

4 24. Interest on Late Payments. In the event that any
5 payments required by Section VI are not made when due, Interest,
6 as provided for in Paragraph 4 l., as to Past Response Costs; and
7 interest as described in Paragraph 7 as to Future Response Costs,
8 shall accrue on the unpaid balance, from the date payment is due
9 through the date of payment.

10 25. Stipulated Penalty. If any amounts due to the United
11 States or to the State under Paragraphs 5 or 7 of this Consent
12 Decree are not paid by the required date, the defaulting Settling
13 Defendant(s) shall pay as a stipulated penalty, in addition to
14 the interest required by Paragraph 24, the sum of \$500.00 per day
15 for each day that such payment is late. Stipulated penalties are
16 due and payable within thirty (30) days of the defaulting

10 seek civil penalties pursuant to Section 122(1) of CERCLA, 42
11 U.S.C. § 9622(1), for any violation for which a stipulated
12 penalty is provided herein except in the case of a willful

11 and the payments that will be made by the Settling Defendants
12 under the terms of the Consent Decree, and except as provided in
13 Paragraphs 10, 26, 29, 30, 32, and 40, the State covenants not to
14 sue or to take administrative action against Settling Defendants
15 pursuant to Sections 106, 107(a), and 113(f)(1) of CERCLA, 42
16 U.S.C. §§ 9606, 9607(a), and 9613(f)(1), Sections 711, 715, and
17 719 of CECRA, Mont. Code Ann. §§ 75-10-711, 75-10-715, and 75-10-
18 719, or Section 7003 of RCRA, 42 U.S.C. § 6973, relating to the
19 Site. Except as provided in Paragraphs 10, 29, and 30, with
20 respect to future liability, these covenants not to sue shall
21 take effect upon the payment of Settling Defendants' respective
22 payments, as described in Paragraph 5. These covenants not to
23 sue are conditioned upon the complete and satisfactory
24 performance by Settling Defendants of their respective
25 obligations under this Consent Decree. These covenants not to

3 c. While the State does not release or covenant not to sue

7 forth the facts that: neither BNRR nor MRI has been named as a
8 defendant in the State's pending natural resource damage case

16 administrative record supporting the 1993 Record of Decision, any
17 post-1993 Record of Decision administrative record, any 1993

17 indirect claim for reimbursement from the Hazardous Substance
18 Superfund (established pursuant to the Internal Revenue Code, 26

21 any other provision of law; (ii) any claim against the United

23 claims arising out of response activities at the Site, including
24 claims based on EPA's selection of response actions. Nothing in
25 this Consent Decree shall be deemed to constitute

1 preauthorization of a claim within the meaning of Section 111 of
2 CERCLA, 42 U.S.C. § 9611, or 40 C.F.R. § 300.700(d).

3 b. The Settling Defendants specifically reserve, and this
4 Consent Decree is without prejudice to: (i) claims or causes of
5 action against the United States, subject to the provisions of
6 Chapter 171 of Title 28 of the United States Code, for money
7 damages for injury or loss of property or personal injury or
8 death caused by the negligent or wrongful act or omission of any
9 employee of the United States while acting within the scope of
10 his or her office or employment under circumstances where the
11 United States, if a private person, would be liable to the
12 claimant in accordance with the law of the place where the act or
13 omission occurred. However, any such claim shall not include a
14 claim for any damages caused by the act or omission of any person
15 who is not a federal employee as that term is defined in 28
16 U.S.C. § 2671; nor shall any such claim include a claim based on
17 EPA's selection of response actions, other than as provided in

i. This Consent Decree does not include releases of claims between ARCO and MRI. MRI and ARCO specifically reserve and exclude from this Consent Decree any and all contract claims or defenses arising under the Agreements with ARCO dated September 19, 1985, and December 18, 1985, and this Consent Decree shall not validate or abrogate such claims, and is not a final judgment on the merits as to such claims. This Paragraph shall not waive

34. Nothing in this Consent Decree shall be construed to create any rights in, or grant any cause of action to, any person not a Party to this Consent Decree. Each of the Parties expressly reserves any and all rights (including, but not limited to, any right to contribution), defenses, claims, demands, and causes of action which each Party may have with respect to any matter, transaction, or occurrence relating in any way to the Site against any person not a Party hereto.

XV. EFFECT OF SETTLEMENT-CONTRIBUTION PROTECTION

35. The Parties agree, and by entering this Consent Decree this Court finds, that the Settling Parties have resolved their liability to the United States and the State as provided herein, and are each entitled, as of the Effective Date of this Consent Decree, to protection from contribution actions or claims as provided by Section 113(f)(2) of CERCLA, 42 U.S.C. § 9613(f)(2), and by CECRA, Mont. Code Ann. § 75-10-719, to their full extent, for Matters Addressed in this Consent Decree. The Matters Addressed in this Consent Decree are: (1) resolution as provided in this Consent Decree of liability of the Parties associated with Past and Future Response costs and past and future response and remedial action(s) regarding the Site; (2) the implementation of the Remedial Design, Remedial Action and Operation and Maintenance at the Site in a cost-effective and

2 timely manner; (3) the resolution as provided in this Consent
3 Decree of liability among the Settling Parties regarding the
4 Site; (4) the resolution as provided in this Consent Decree of
5 liability of the Settling Parties for the migration of any
6 hazardous or deleterious substances consisting of
7 pentachlorophenol, PAHs, TPHs, BTEX, dioxins, furans, or related
8 constituents from the MPTP operations; and (5) the resolution as
9 provided in this Consent Decree of liability of the Parties
10 associated with the alleged releases or threatened releases of
11 Waste Material at, on, or from the Site.

12 36. The Settling Parties agree that, with respect to any
13 suit or claim for contribution brought by them for matters
14 related to the Site or this Consent Decree, except with respect
15 to any natural resource damages suits or claims filed or to be
16 filed, including, but not limited to, filings in State of Montana
17 v. ARCO, (CV 83-317-HLN-PGH), or with respect to United States v.
18 ARCO, et al., (CV 89-39-BU-PGH), they will notify the United

XXIV. MODIFICATIONS

51. No modifications shall be made to this Consent Decree without written notification and written approval of the United States, the State, and the Settling Parties or by order of the Court.

52. Nothing in this Consent Decree shall be deemed to alter the Court's power to order, enforce, supervise, or approve modifications to this Consent Decree.

XXV. APPENDICES

53. The following appendices are attached to and incorporated into this Consent Decree: "Appendix A" is the United States' estimated calculation of the cost of the remedy as set forth in the 1993 Record of Decision; "Appendix B" is the 1993 Record of Decision; and "Appendix C" is a map of the Site with narrative description.

10 and enters this Consent Decree. The Parties shall not be deemed
11 to have waived any defenses or objections to the State's
12 complaint by not answering, objecting to, or otherwise responding
13 to such pleading. If this Consent Decree is not entered by the
14 Court, the State's complaint shall not be accepted for filing in
15 this Consolidated Litigation, and the State shall not be deemed
16 to have submitted itself to the jurisdiction of the Court, and
17 the Parties shall not be deemed to have waived any defenses or
18 objections to the State's being added as a party to this action.

19 56. If for any reason this Court should decline to approve
20 this Consent Decree in the form presented, this agreement is
21 voidable at the sole discretion of any Party and the terms of the
22 agreement may not be used as evidence in any litigation.
