The Coal-Fired Generating Unit Remediation Act

Annual Status Report 2021/2022

Sarah,

As you requested, this letter provides a status report for calendar years 2021 and 2022 for the Colstrip Units 1&2 Remediation Plan that was prepared in accordance with Mont. Code Ann. § 75-8-105, MCA, titled The Coal-Fired Generating Unit Remediation Act. The Colstrip Units 1&2 Remediation Plan dated August 2020 was approved by MDEQ on December 3, 2020. The initial remediation work described in the Plan was completed in 2020. This letter provides the activities related to the referenced Remediation Plan that have been conducted during calendar years 2021 and 2022.

Regarding the two previous petroleum release sites in the Units 1&2 area that were identified in the Remediation Plan (Releases 332 & 562), Petroleum Mixing Zone Closure Summary Reports were provided to MDEQ in December of 2020. These reports provide the basis for a Petroleum Mixing Zone (PMZ) site closure for both releases. During 2021 and 2022, additional discussions and information was provided to MDEQ with the understanding that site closures would be approved for these releases. On March 30, 2023, Talen Montana received draft PMZ Deed Restrictions from MDEQ for these releases and expects to have them finalized in the near future.

The Colstrip Water Feasibility Study (75-8-110 MCA) was completed in 2022 as required. The Colstrip Owners collaborated with the Stakeholders in selecting a qualified consultant to conduct the Study. DOWL was selected and performed the Study with input from the Plant providing existing water supply information and by conducting several Stakeholder meetings in Colstrip to get input as the Study progressed. The final report was submitted to MDEQ on November 1, 2022 and shared with the Stakeholders.

Groundwater remediation and process pond closures are discussed in the Remediation Plan under Section 5.2.2.1 AOC and Federal CCR Rule. Related activities for 2021 and 2022 are described below.

Here is a summary of contracts issued at Colstrip from January 1 – September 30 in 2022 that were issued meeting prevailing wage requirements.

For Units 1&2, we had 15 contract releases in 2022 related to remediation activities that were issued meeting prevailing wage requirements. The types of contractors hired meeting the prevailing wage requirements included ironworkers, boilermakers, carpenters, pipefitters, construction equipment operators, construction equipment mechanics, laborers, electricians, crane operators, and sheet metal workers.

For Units 3&4, we had 16 contract releases in 2022 related to remediation activities that were issued meeting prevailing wage requirements. The types of contractors hired meeting the prevailing wage requirements for these contracts included ironworkers, boilermakers, carpenters, pipefitters, construction equipment operators, construction equipment mechanics, laborers, electricians, crane operators, linemen, and sheet metal workers.
