SUBJECT: LARGE QUANTITY HAZARDOUS WASTE GENERATOR ANNUAL/BIENNIAL REPORT FOR CALENDAR YEAR 2025

General Information

The Administrative Rules of Montana (ARM) 17.53.603 require large and small generators of hazardous waste to file an annual report. Additionally, the 40 Code of Federal Regulations (CFR) 262.41 (as incorporated by reference in ARM 17.53.601) requires large quantity generators to submit a biennial report. These reports are due by March 1 for the previous calendar year's activities. You are receiving this message because your site was registered as a large quantity generator during calendar year 2025.

Please follow the links provided for detailed instructions and the appropriate forms required for completing your annual/biennial report for calendar year 2025. Please read the instructions carefully so that the report will accurately reflect the 2025 hazardous waste activities at your site.
