**TO:** USED OIL PROCESSORS/RE-REFINERS/TRANSFER FACILITIES  
**SUBJECT:** USED OIL BIENNIAL REPORT FOR CALENDAR YEAR 2025

#### **General Information**

The Department of Environmental Quality's (DEQ) records show that you have registered and are classified as a used oil processor, re-refiner, or transfer facility storing used oil greater than 35 days. You are required to submit a report pursuant to the Administrative Rules of Montana (ARM) 17.53.1401. A registration fee is not assessed for these classifications.

ARM 17.53.1401 adopts, by reference, the used oil regulations set forth in the Code of Federal Regulations (CFR). 40 CFR 279.57(b) requires used oil processors and re-refiners to submit a biennial report. In addition, transfer facilities that store used oil for more than 35 days are subject to the regulations of used oil processors and re-refiners (40 CFR 279.45(a)).

Used oil processors, re-refiners, or transfer facilities who store used oil more than 35 days must submit a document which reports the following information concerning used oil activities during the previous calendar year:

1. The EPA Identification Number, Name, and Address of the used oil processor, re-refiner, or transfer facility storing used oil greater than 35 days.
2. The quantities of used oil accepted for processing or re-refining, and the manner in which the used oil was processed or re-refined, including the specific processes employed.
