**WPCSRF BIL Emerging Contaminants Funding**

The *primary* purpose of the Intended Use Plan (IUP) is to identify the proposed annual intended uses of the federal and state funds available to the Montana Water Pollution Control State Revolving Fund (WPCSRF) program. Federal dollars appropriated in one year are available for use in the next year (i.e., the FFY22 appropriation is available in FFY23). On November 15, 2021, the Bipartisan Infrastructure Law (BIL) was signed into law. The BIL reauthorized the WPCSRF program for federal fiscal years 2022 through 2026 with funding levels set through the annual appropriations process. With the enactment of BIL, starting in FFY22 Montana's WPCSRF program will receive an emerging contaminants (EC) capitalization grant. The EC funds are to be used to help communities address emerging contaminants that include substances or microorganisms which are known or anticipated in the environment, that may pose newly identified or re-emerging risks to human health, aquatic life, or the environment. These funds are to be provided as entirely forgivable loans and do not require State match. Montana's WPCSRF federal EC grant for federal fiscal year 2022 is \$459,000. The CWSRF program has been unable to identify any projects that can utilize the CWSRF EC capitalization grant allotted to Montana in FFY22. The Montana WPCSRF program proposes to transfer these funds to the Montana DWSRF program's Emerging Contaminant Fund which has identified several projects that address emerging contaminants and can utilize both the WPCSRF EC capitalization grant and the DW EC capitalization grant. Per SRF statute and regulation, states have the flexibility to transfer funds between the CWSRF and DWSRF. Information regarding transferring funds can be found in the March 8, 2022, memorandum entitled *Implementation of the Clean Water and Drinking Water State Revolving Fund Provisions of the Bipartisan Infrastructure Law*. The statutory ceiling of funds available to transfer is 33% of the DWSRF Emerging Contaminant allotment. In FY 2022, the DWSRF allotment is \$7,555,000 and 33% of the allotment equals \$2,493,150; thus allowing 100% of the CWSRF Emerging Contaminant allotment (equal to \$459,000) to be transferred to the DWSRF Emerging Contaminant Program."

For SFY 2023, Montana has elected to transfer all WPCSRF FFY 2022 EC grant funds (\$459,000) to the DWSRF program. **Table 1** summarizes transfers to date, and funds still available for transfer for the EC grant.

This amended IUP will be presented at a public meeting to allow an opportunity for public comment on the transfer of CWSRF program’s EC funds to the DWSRF program’s EC fund. Total EC funds available for drinking water projects after the transfer is complete are:

DWSRF \$7,555,000  
 CWSRF \$ 459,000  
 Total: \$8,014,000

Public Review and Comment – One public meeting was held on June 14, 2023, in Helena to discuss the Amendment to the SFY23 Water Pollution Control State Revolving Fund Intended Use Plan and Project Priority List and to allow public comment on the draft IUP amendment. Public notice concerning the PPL and IUP was posted in major newspapers across the state, and the notice and draft IUP amendment was published on DEQ’s website. There was a 30-day public comment period for the public to review and comment on the draft IUP. That comment period ended June 30, 2023.
