MONTANA WATER POLLUTION CONTROL STATE REVOLVING FUND SFY25 INTENDED USE PLAN

Revised Additional Subsidy Awarded to Projects

The primary purpose of the SFY25 Intended Use Plan (IUP) is to identify the proposed annual intended uses of the federal and state funds available to the Montana Water Pollution Control State Revolving Fund (WPCSRF) program for the planning, design, and construction of water pollution control projects. Under the Bipartisan Infrastructure Law, the WPCSRF programs must provide additional subsidization (AS). The Montana WPCSRF program awards AS in the form of principal forgiveness (PF) through an affordability assessment for those projects deemed ready to proceed to construction in SFY25. The affordability assessment takes into consideration user rates per median household income, unemployment rates, population trends, community size, and low- to moderate- income data. Principal forgiveness is capped at \$850,000 or 49% of the long-term SRF loan amount, whichever is less for the base and supplemental cap grants in SFY25.

After finalizing the SFY 25 Intended Use Plan and Project Priority List in May 2024 two (2) projects have requested they be added to the IUP/PPL to be eligible for WPCSRF loans in SFY25, several projects requested additional principal forgiveness (PF) due to escalating project costs which we are able to accommodate due to twelve (12) projects that were awarded principal forgiveness choosing to no longer pursue SRF funds or reducing their loan request thereby making those funds available for other projects.

Attachment I of this amendment lists the projects that have been added to the IUP, those projects that have returned PF, and those projects that have received increased award amounts. **Attachment II**, the Project Priority List (PPL), is a complete list of all eligible projects that are considered possible candidates for assistance from the WPCSRF program (with either the base or supplemental cap grant funds) in SFY25. All other aspects of the original IUP dated 5/29/24 remain in effect.
