

# PUBLIC NOTICE NO. MT-21-25 October 25, 2021

#### PURPOSE OF PUBLIC NOTICE

The purpose of this notice is to state the Montana Department of Environmental Quality's (DEQ) intention to issue a General Permit as described in this notice and to hold a public hearing on the issuance of this permit. This permit is issued by the Department under the authority of 75-5-402, Montana Code Annotated (MCA); the Administrative Rules of Montana (ARM) 17.30.1301 *et seq.*, Montana Pollutant Discharge Elimination System (MPDES); and Sections 402 and 303 of the Federal Clean Water Act. The Water Protection Bureau has prepared a draft permit for the facility listed below. This fifth generation General Permit covers discharges of storm water from Small MS4s including storm water runoff, snow melt, surface runoff, and/or drainage that transports pollutants to waterways via storm sewer systems. The renewal is for a five-year cycle and will continue to provide protection of state waters by requiring owner/operators to maintain, update, and enforce a Storm Water Management Program.

DEQ will respond to all significant comments and issue a final decision within sixty days of this notice or as soon as possible thereafter. The complete administrative record, including permit application and other pertinent information, is maintained at the Water Protection Bureau office in Helena and is available for review during business hours.
