## Overview of eMACS Registration Steps for Nonpoint Source and Wetland Program Partners

For all upcoming nonpoint source grant applications, including the focus watershed application, all applicants will need to be registered ahead of time with the state's online platform eMACS (electronic Montana Acquisition and Contracting System).

Because eMACS is typically used to manage the state's invitations for bids for things like janitorial services and building renovations, we recognize that some of the wording and processes may be unfamiliar. - Go to the Vendors side of the page, click the 'Registration' dropdown, and then click the 'Vendor Portal' button.
- Enter your email address. If you don't have an account, it will prompt you to create one. The person creating an account should be the person authorized to submit grant applications on behalf of your organization.
- Required fields are marked with a



- Enter **Company Name** (i.e. organization name) and **Contact Info** and **create a Login.** Tax ID Number and DUNS Number (now UEI-Unique Entity Identifier number) are optional fields.
- You will receive an email to create your account and log in.
- Once logged in, you will be navigated to a "Manage Registration Profile" page. You can find the Manage Registration Profile page by clicking the gear icon on the left side of the screen.
- Follow the next several steps to complete the registration process
  - Company Overview (ie your organization)
  - Business Details: Enter at least one commodity code to list products and services your organization provides. This allows you to receive and access grant/solicitation opportunities.
     Please note the available codes may not fully reflect your work, just use your best judgment.
     Suggested codes related to Nonpoint Source work:
    - 1619 Environmental Services Stream Restoration
    - 1402 Educational Services

- Contacts: The system requires you to enter a contact person for Fulfillment and Sales.
  Additional contact types are optional. For Nonpoint Source contract work, think of the Fulfillment role as "Contract Signatory" and the Sales role as "Contract Liaison". The contacts you provide will receive emails about grants and solicitation opportunities.
- Diversity: Optional, non-profits and government entities can decline or choose Do Not Qualify.
- Certify & Submit

## **Next Steps**

As a registered vendor with the State of Montana, the contacts listed in your profile will receive automated email notifications for upcoming Nonpoint Source and Wetland grant opportunities and other applicable solicitation opportunities, updates/changes, and important date reminders. It shouldn't be more than a couple email notifications per month. At the time of writing this guidance, there were 52 grant/solicitation opportunities (known as 'events'), two of which applied to the above recommended codes (1619 and 1402).
